## DISCUSSION AND POSSIBLE ACTION REGARDING ACCOUNTING OF REAL PROPERTY TRUST

Durand Crosby, Ph.D., Chief of Staff and Operations, reminded the Board members that several years ago the legislature passed a law mandating that the department place all of its real property into a trust to prohibit property from being sold without further legislative action. He further stated that as board members they also serve as trustees over the department's land trust and meet at least once a year so that the department can present an accounting of all of the land held in the trust. He presented the trustees an accounting of the real property trust report showing the properties that ODMHSAS currently holds. .Dr. Crosby mentioned that the Department has been working for some time on a plan to sell some of the land in Norman in hopes of building a new hospital, but we need to be sure that the sale will net sufficient proceeds to either build a new hospital, or refurbish existing property to house the hospital. When the details of the plan are finalized, he will bring it to the Board for approval. There were no questions regarding the report.
