Rule revisions also include amended language to align with programmatic changes for residential, halfway house, and medically supervised withdrawal management providers, including a requirement for all residential level of care providers to provide access to medication assisted treatment, changes to requirements for treatment hours for dependent children in residential and halfway house facilities, and the addition of language that describes the Certificate of Need assessment process applicable to certain newly certified providers intending to enroll as a Medicaid provider. Revisions also include other clean-up language regarding assessments, service planning and discharge planning.
