#### **DISCUSSION REGARDING THE REPORT FROM THE ADMINISTRATIVE RULES SUBCOMMITTEE**

Dr. Wilse presented the report from the Administrative Rules Subcommittee as follows:

The Administrative Rules Subcommittee met on Tuesday, September 10, 2024.

Ms. Melissa Miller, Chief of Policy and Provider Regulation, presented the emergency rule changes to Chapter 70: Standards and Criteria for Opioid Treatment Programs. The chapter is included in your board book.

- Chapter 70 emergency rules are being proposed to align state requirements with changes to federal regulations within 42 CFR Part 8.
- Language precluding individuals from receiving treatment based on a number of previous withdrawal episodes is removed and replaced with new guidelines. Revisions also include new language that prohibits opioid treatment programs from requiring participation in treatment services for individuals to receive medications from the program.
- These emergency rules were posted for a short public comment period. No comments were received.
- These emergency rules will be submitted to the Governor for approval upon Board approval and will become effective upon Governor approval.
- These emergency rules will be followed by permanent rule changes to Chapter 70 that will include these and other desired language changes.

The Administrative Rules Subcommittee recommends that the Board accept the changes to Chapter 70.

Ms. Miller is available to answer any questions the Board may have.

## **CHAPTER 70. STANDARDS AND CRITERIA FOR OPIOID TREATMENT PROGRAMS**

### **FINDING OF EMERGENCY:**

The proposed rule revisions to Chapter 70 update language to align with changes in federal regulations at 42 CFR Part 8.

### **SUMMARY:**

Language precluding individuals from receiving treatment based on the number of previous withdrawal episodes as well as language precluding individuals from receiving medications based on participation in other treatment services is removed, and new language replaces these restrictions with new guidelines.

Mr. Henderson presented the Finance Committee report as follows:

The Finance Committee met Wednesday, September 18, 2024.

### **DISCUSSION AND POSSIBLE ACTION REGARDING THE FY-2024 MONTHLY FINANCIAL REPORT**

Mr. Henderson stated it was a rather lengthy meeting given we were covering 2-year, 2024 and 2025, budgets.

Rich Edwards presented the FY-2024 Finance Report for the month ending August 2024. He presented the budget to actual comparison reports as follows:

For FY-2024, revenue collections are trending below the projections by 4.4% or \$25 million due to billing issues surrounding managed care implementation and some grant funds that have not yet been received. Expenditures are trending under budget by 8% or \$50 million due to ongoing end of year closeout process to pay final claims. The year-to-date net variance of the agency is a positive 4.1% or \$25 million.

**DISCUSSION AND POSSIBLE ACTION REGARDING THE FY-2025 MONTHLY FINANCIAL REPORT**

Mr. Henderson stated we also reviewed a little more briefly the FY-2025 Finance Report ending August 2024.

Mr. Edwards presented the FY-2025 Finance Report for the month ending August 2024. He presented budget to actual comparison report as follows:

For FY-2025 revenue, collections are almost exactly matching the projections for the first two months of the year. Collections are \$200,000 above the estimate. Expenditures are trending under budget by 16% or \$98 million. That is typical at this time of year due to delays in establishing new programs and fully encumbering all contracts. The year-to-date net variance for the agency is a positive 16.4% or \$98.5 million.

Stephanie's work has earned her the respect of her peers and the community. This year she was recognized as Peer Recovery Support Specialist of the Year by the Oklahoma Coalition of Advocates. For Stephanie, the true reward comes from the relationships she builds and the strength she helps others find within themselves. She is honored to share her journey with you today.
