## DISCUSSION AND POSSIBLE ACTION RE: ACCOUNTING OF REAL PROPERTY TRUST

Dr. Durand Crosby stated that the Board Members sit as the Trustees of the Department's Land Trust. He stated that several years ago the Legislature passed a statute requiring the Department to place all of its real property into a Land Trust to be held in perpetuity, or until the Legislature gave approval for the Department to take it out for sale. The statute also states that all proceeds from the sale of the land must be used for Department infrastructure. Pursuant to an Operating Agreement, the Department handles the use of the land, such as leases, and each year provides an annual accounting of the land that is in the Trust. Dr. Crosby stated that a copy of the Land Trust's annual report is provided in the Board book.

Dr. Crosby stated that he had nothing further to add but noted that Mr. Shawn McCarty, the Department's Property Manager, was in attendance to answer questions.
