The existing condition (2022 traffic) TNM analysis results indicated that no receptors approach, meet, or exceed any of the NAC criteria. The future no-build condition (2042 traffic) TNM analysis results indicated one (1) receiver is projected to experience exterior noise levels that approach 67 dB(A) LEQ (h). No receivers will experience a substantial increase (15 dB) over the existing sound levels; the highest increase is 1.5 dB(A). The future condition (2042 traffic) TNM analysis results indicated two (2) receivers are projected to experience exterior noise levels that exceed 67 dB(A) LEQ (h). No receivers will experience a substantial increase (15 dB) over the existing sound levels; the highest increase is 9.4 dB(A). Noise abatement in the form of freestanding noise walls was considered for the impacted receptors. The two impacted receivers are located miles apart, and one is a travel trailer on property that would become ROW as a result of the proposed project. Therefore, as was found in the 1998 Noise Study, due to the low density of residences and the local access requirements for properties located along the proposed project area, a continuous barrier necessary to provide a 7 dBA reduction is not feasible or reasonable, and no mitigation is recommended in these areas.
