RULE IMPACT STATEMENT

Pursuant to the Administrative Procedures Act, Section 303(D) of Title 75 of the Oklahoma Statutes, the Oklahoma Department of Transportation ("ODOT") hereby submits the following Rule Impact Statement for the amendment of PERMANENT rules contained in OAC Title 730:50-5-17. Certification of Operators of Escort Vehicles for Hire.

Brief Description of the Purpose of the Proposed Rules:

The Oklahoma State University College of Engineering, Architecture, and Technology (CEAT) is amending its collaboration with ODOT to incorporate the materials testing and certification, Local Technical Assistance Program (LTAP), Tribal Technical Assistance Program (TTAP), and the Pilot Escort Certifications of ODOT within the Professional Development of CEAT. The proposed rule enables this partnership.

Description of the classes of persons who most likely will bear the costs of the proposed rule and any information on cost impacts received by the Agency from any private or public entities:

Students wishing to be certified in these areas will bear the cost of the certification and classes, and the Agency has not received any information regarding the cost impact received by the Agency from any private or public entities.

Description of the classes of persons who will benefit from the proposed rule:

The proposed rule will benefit tribal, municipal, and county governments lacking this training.

Description of the probable economic impact of the proposed rule upon affected classes of persons or political subdivisions, including a listing for all fee changes and, whenever possible, separate justification for each fee change:

The proposed rule will positively impact tribal, municipal, and county governments by providing them with training opportunities and certification. It does not require a fee change.

A determination was made that the proposed rule would positively affect local governments and that cooperation is not required to implement or enforce the rule.
