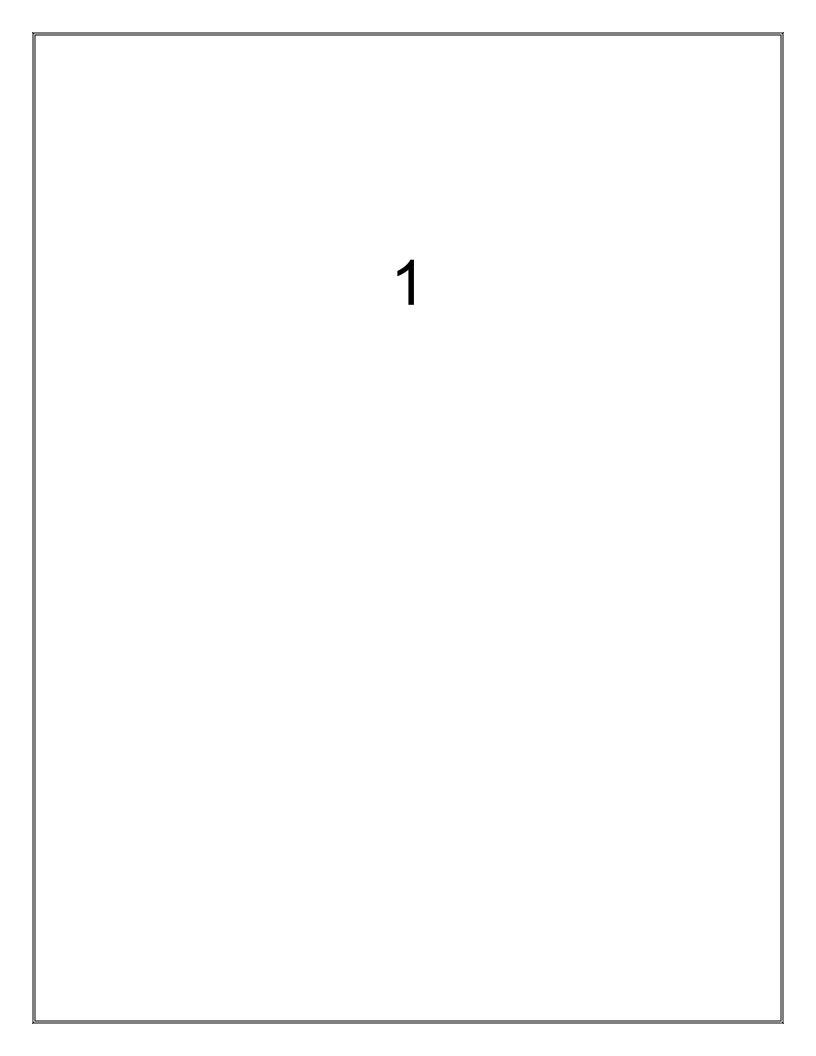

Director Gatz began his report by thanking the students for their attendance and briefly described the many different opportunities within Oklahoma Transportation.

Gatz reminded the Commission the current appropriations run out on December 20th of the Continuing Resolution and remained optimistic in expressing hope for a full year's appropriation.

Director Gatz reminded the Commission and the traveling public of the potential upcoming winter weather and the holiday traffic and to be mindful and aware at all times. As winter weather approaches, Oklahoma will see frozen precipitation and Gatz advised the public to have extra jackets/blankets, water bottles and snacks in the event of hazardous conditions on the roadways. The Department is responsible for more than 30,000 lane miles of highway in the state and Gatz assured that ODOT is prepared for inclement weather with over 500 different pieces of equipment and the salt sheds are full.

Gatz closed the report by recognizing Joni Seymour as she has served in the Chief Innovation Officer role for the Department, and will now transition into a full time role as the Deputy Director at Oklahoma Turnpike Authority. He offered his thanks for all the work on technology initiatives and some organizational innovation and wished her well on her new endeavor.

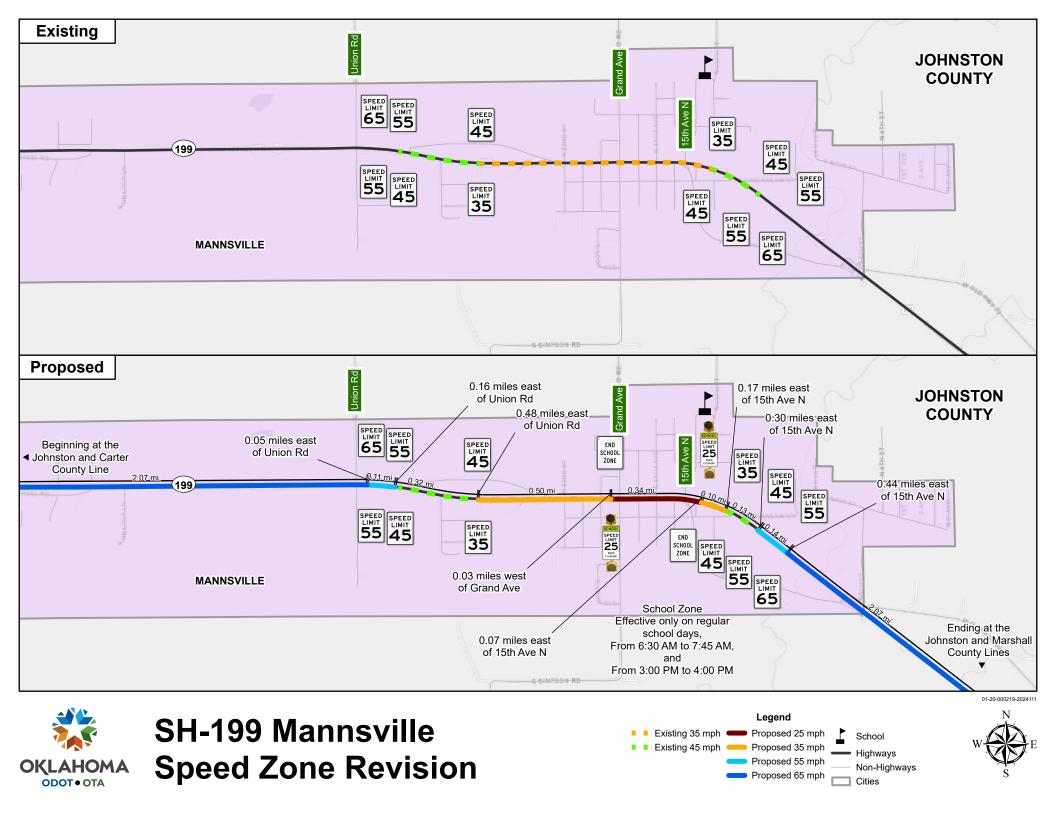


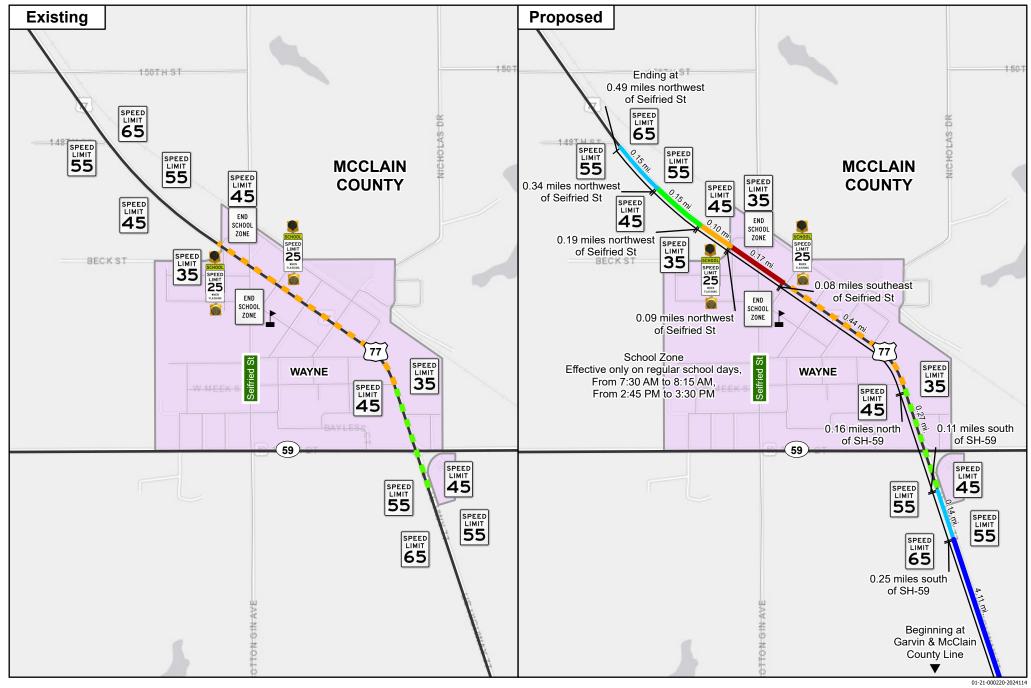


SH-259A Broken Bow/Hochatown Speed Zone Revision





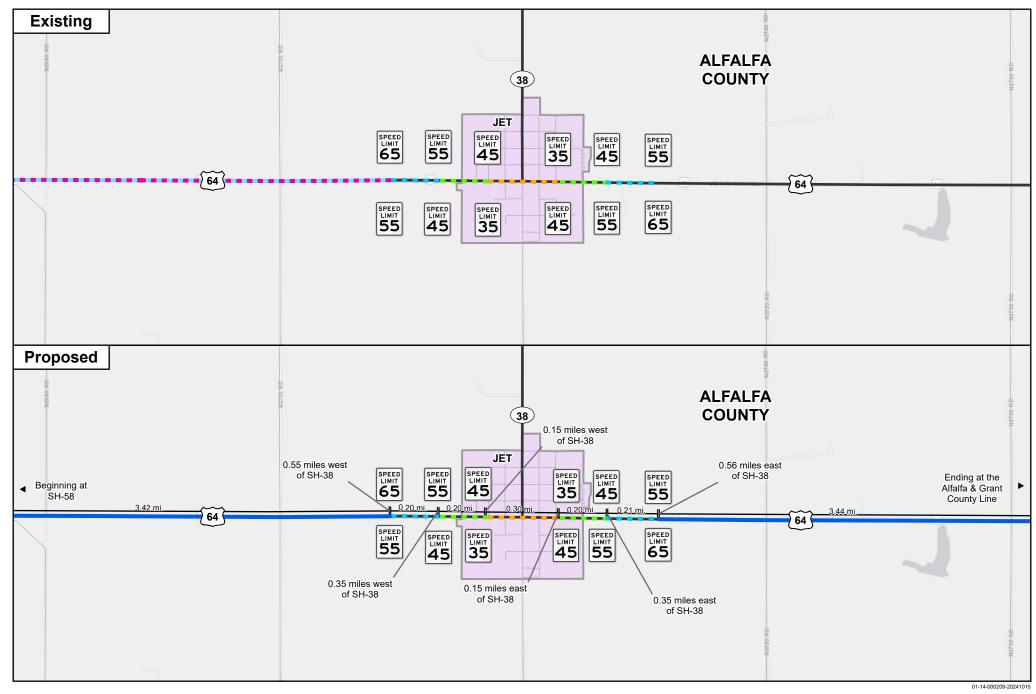






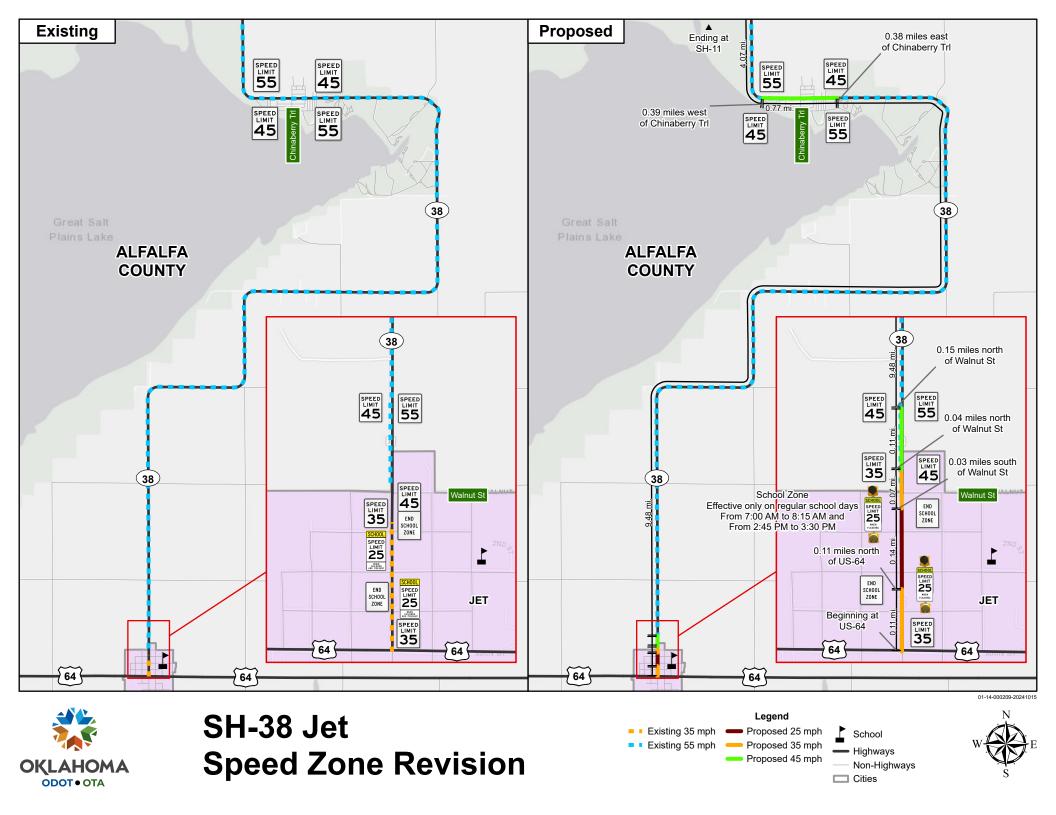
US-77 Wayne Speed Zone Revision







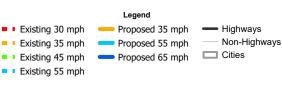




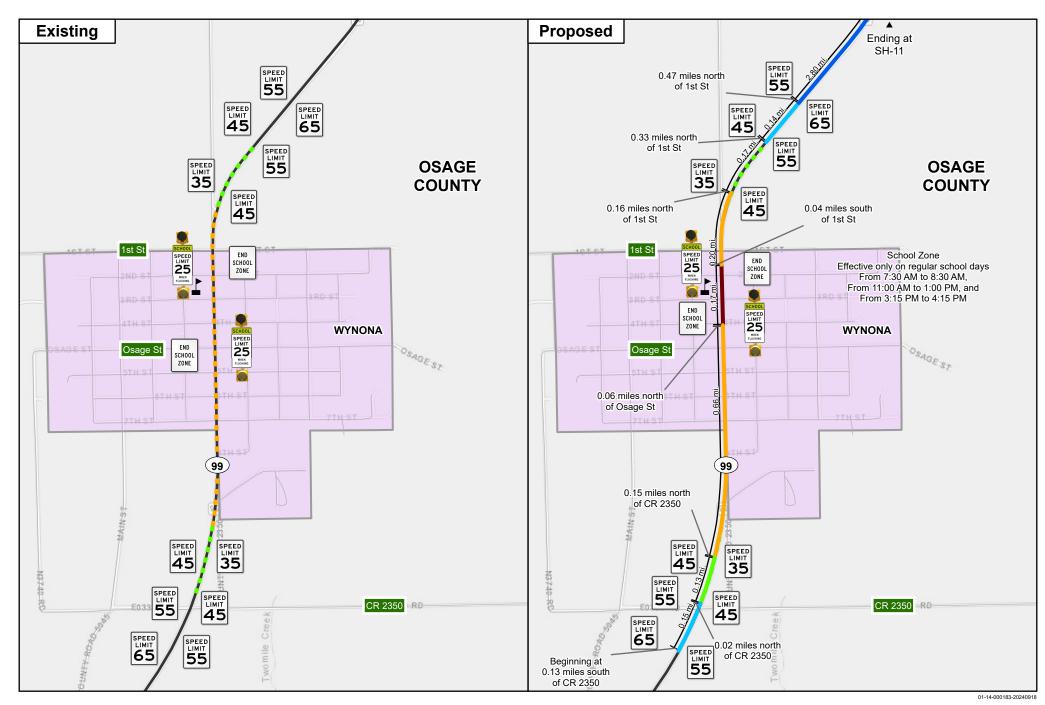




SH-20 Salina Speed Zone Revision

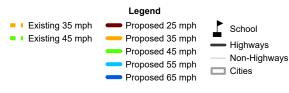




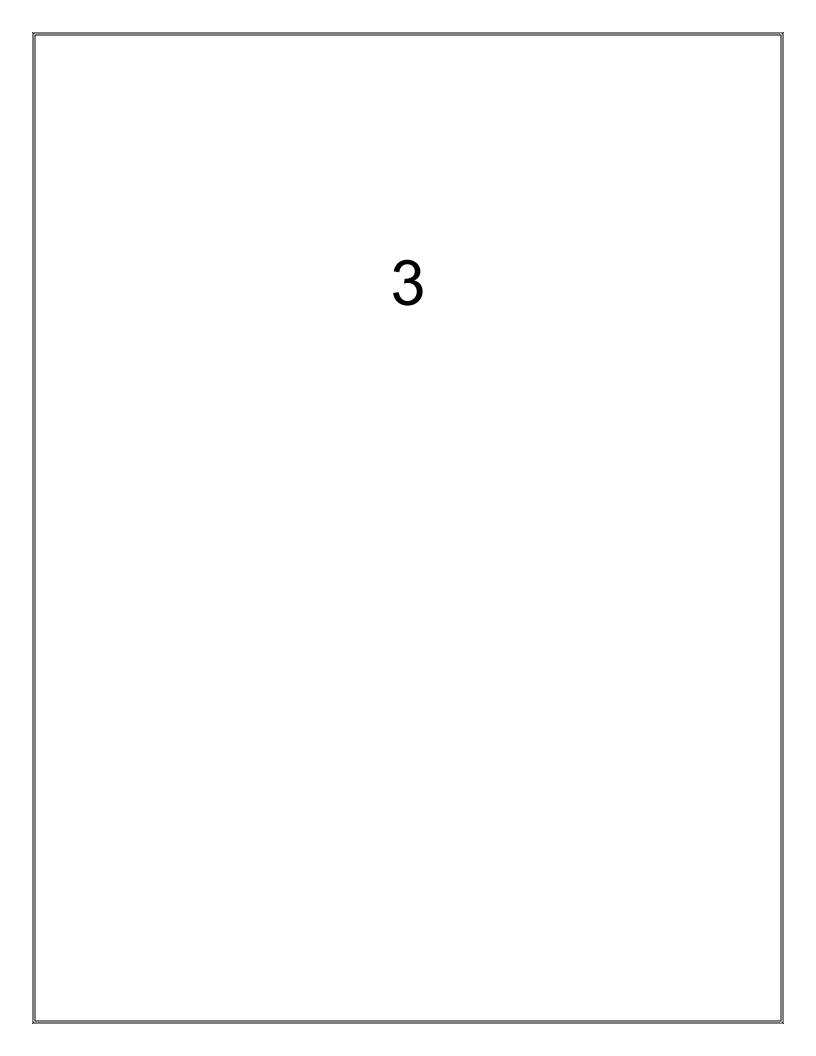

SUBJECT: Assignment of Certain Contracts for Highway Construction Agreement between J. and R. Sand Company, Inc., and Haskell Lemon Group, LLC

LOCATION: Cimarron, Ellis & Texas Counties

J. and R. Sand Company, Inc., and Haskell Lemon Group, LLC, have entered into a certain Assignment and Assumption Agreement dated the 12th day of November, 2024 (attached to this item) in which J. and R. Sand Company, Inc., has agreed to assign six of its contracts for highway construction to Haskell Lemon Group, LLC. The Department approves of this Agreement and requests the Commission's consent to this assignment of the Contracts listed in the Agreement to Haskell Lemon Group, LLC., by resolution of the Commission pursuant to State law at Title 61 O.S. § 120.

ASSIGNMENT AND ASSUMPTION AGREEMENT

This Assignment and Assumption Agreement (this "Agreement"), is made as of <u>Nov.12</u>, 2024, among Haskell Lemon Group, LLC, an Oklahoma corporation (the "Assignee"), on the one hand, and J. and R. Sand Company, Inc., a Kansas corporation ("Assignor"), on the other hand.

Assignor and Assignee are contemplating entering into an Asset Purchase Agreement (the "Purchase Agreement"), pursuant to which Assignor would assign and Assignee would assume the contracts and agreements set forth on Exhibit A hereto (the "Acquired Contracts") at the closing of the transactions contemplated by the Purchase Agreement, contingent upon the approval of the Oklahoma Transportation Commission's prior written consent of the assignment of the Acquired Contracts from Assignor to Assignee pursuant to the Public Competitive Bidding Act at 61 OS §120, the execution and delivery of the Purchase Agreement by Assignor, Assignee and the other parties thereto, and the satisfaction of the conditions to closing agreed to by the parties (the "Closing Date").

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, tl1e parties agree as follows:

Effective as of the Closing Date, Assignor hereby sells, assigns, grants, conveys and transfers to Assignee all of Assignor's right, title and interest in and to the Acquired Contracts.

Effective as of the Closing Date, Assignee hereby accepts the foregoing assignment of the Acquired Contracts and agrees to pay, perform and discharge, as and when due, the obligations expressly set forth in writing in the Acquired Contracts that are to be performed after the Closing Date, in each case, except to the extent arising from a breach or default, whether with or without notice, the passage of time or both, of any obligation to be performed on or before the Closing Date.

This Agreement shall be governed by and construed in accordance with the internal laws of the State of Oklahoma without giving effect to any choice or conflict of law provision or rule (whether of the State of Oklahoma or any other jurisdiction) that would cause the application of laws of any jurisdiction other than those of the State of Oklahoma.

This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Agreement delivered by facsimile, email or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Agreement.

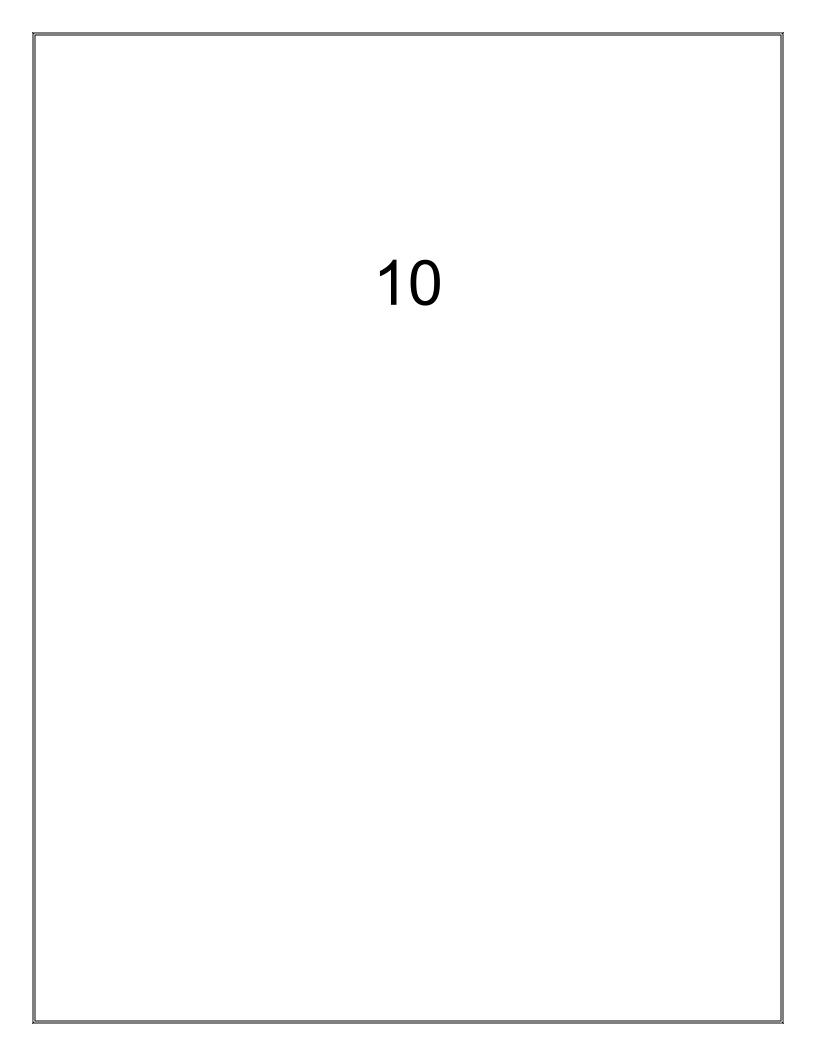

SUBJECT: Negotiated Settlement of Contractor's Claim – APAC-Central, Inc.

LOCATION: District VIII – Tulsa County, SH-20 near Skiatook

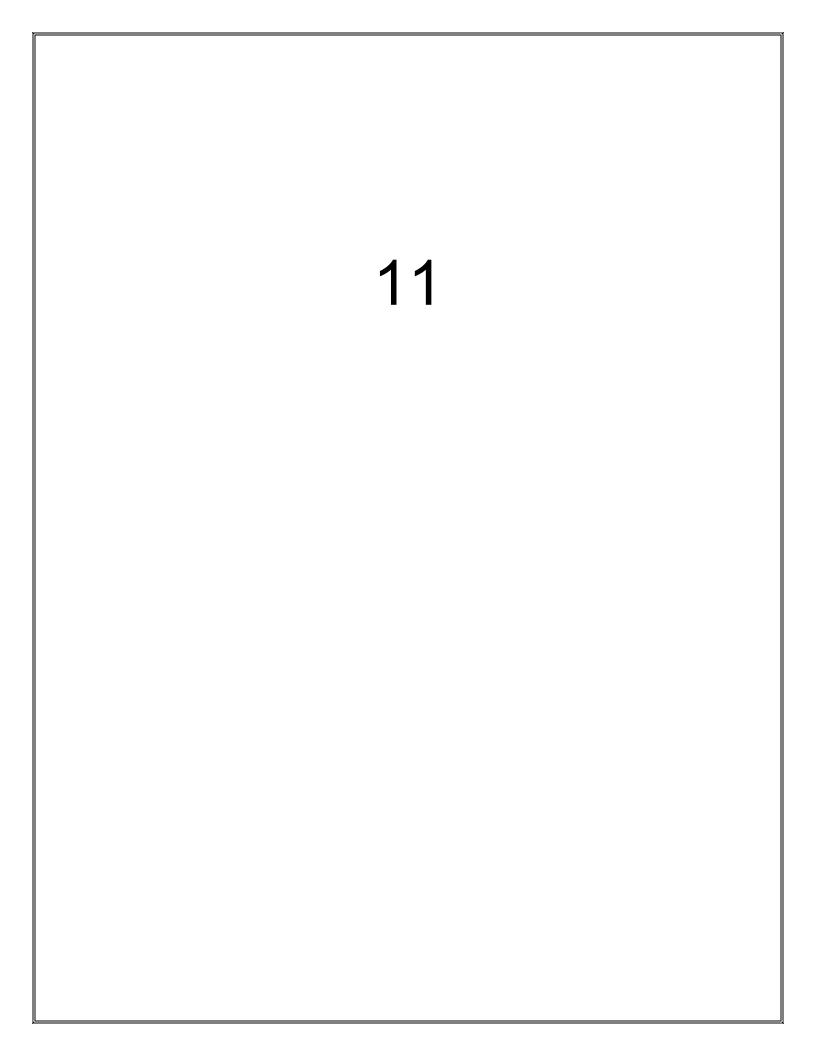
This project, STP-172B(360)SS, Job Piece 24346(04), was a Grade, Drain, Surface and Bridge contract (Contract ID 200092) awarded by the Oklahoma Transportation Commission on February 3, 2020 to APAC-Central, Inc. for a total contract amount of \$15,450,000. Contract time was 350 calendar days.

There are two parts to this settlement. The first is for extended jobsite overhead. Multiple utility delays, along with differing site conditions, caused the contractor to alter the work schedule and be onsite much longer than expected and, as a result, the contractor incurred significant overhead costs that could not have been anticipated in their original bid. The total documented amount for this delay is \$279,092.42.

The second part of this settlement is for differing site conditions. Once earthwork operations for the project began, the contractor encountered large areas of unsuitable subgrade that had to be removed and replaced with additional borrow material, which significantly slowed production. Because of these conditions, the contractor's means and methods also had to be altered to include the opening of a second borrow pit which increased haul distances, and the necessitated use of smaller equipment due to these unforeseen conditions which decreased production even further. The total negotiated amount for this item equals \$667,228.28.

Supporting documentation was required for both portions and has been thoroughly reviewed, and through subsequent extensive negotiations the Department and the contractor have agreed to the final amounts. The necessity for this claim is recognized by the Department, and it is recommended that the Commission authorize a settlement in the amount of \$946,320.70. Because this amount, along with previous changes, exceeds the statutory limit of 10% on new items, Commission approval is required.

Approval is recommended.
