# **2024 OK MONARCH SUMMIT**

August 20-21, 2024

### Hosted by the Oklahoma Monarch & Pollinator Collaborative

Located at Oklahoma City Zoo & Botanical Garden's Rosser Conservation Education Center

With the announcement of this year's record low monarch population overwintering numbers, we recognize the need for renewed efforts to aid with the protection and recovery of this ecologically important ambassador species.

To prepare for the monumental work and investment ahead, the Oklahoma Monarch and Pollinator Collaborative (OMPC) is hosting key stakeholders for a two-day working summit focused on identifying opportunities to increase monarch and pollinator habitat in Oklahoma.



### **PURPOSE**

The purpose of the Summit is to bring together various stakeholders to identify threats/challenges to the Monarch butterfly, as well as potential solutions to save the Monarchs from further decline. The findings will be utilized to update the <u>Oklahoma Statewide Monarch Conservation Action Plan</u> and provide an updated roadmap for the Oklahoma Monarch & Pollinator Collaborative.

### **BACKGROUND**

The Action Plan was originally launched in 2018 and was guided by findings from the first <u>OK Monarch Summit in 2016</u>. Over the last 6 years, the OMPC managed work groups to complete the objectives in the Action Plan. It is now time to update the Action Plan with new objectives for OMPC to achieve over the next 3-5 years.

### **GOALS**

- Identify major threats in Oklahoma to the Monarch butterfly's survival.
- Identify potential solutions to the threats.
- Identify major opportunities for increased Monarch habitat.
- Identify needed work groups and potential work group members to develop and implement new objectives to be incorporated into the statewide Monarch Action Plan.

### **STRUCTURE**

- This event is a two-day working summit. Not a conference/symposium.
- Dr. Kristin Baum with Monarch Watch will be the keynote speaker.
- Attendees will be guided through discussions and activities by Brooking Gatewood with Ufacilitate, the third-party Summit facilitator.

### **Statewide Plan Actions**

- Compile a list of entities that own such lands in the state (woodlands, wetlands, rangelands, prairie, etc)
- Engage key contacts on participating in OMPC efforts.
- Inventory lands.
- Encourage monarch-friendly land management.
- Engage farmers, ranchers, and other ag specialists in cropland and rangeland working groups to identify agricultural land types most compatible with monarch conservation and develop best management toolkits.
- Offer education and training to interested ag and ranch land managers.
- <u>CONSERVATION LANDS PRIMARY GOAL:</u> To maintain and increase a diverse array of nectar source plants and milkweeds on potential conservation lands, both public (state and federal government) and private (non-governmental land trusts and organizations) through management and restoration.
  - OBJECTIVE A: Engage both public and private entities that own and manage protected grasslands and rangelands to both maintain and increase (when and where feasible) available habitat for monarch butterflies.
    - STRATEGY 1: Identify Target Agencies Identify agencies and organizations that own or manage conservation lands that currently, or have the potential to contain habitat for monarch butterflies.
    - <u>STRATEGY 2:</u> Habitat Inventory on Conservation Lands Assess the current availability of monarch butterfly habitat on both public and private conservation lands.
    - <u>STRATEGY 3:</u> Support Managers of Public and Private Conservation Lands Compile and distribute resources to support the management of conservation lands for monarchs and other pollinators by developing a one-stop-shop web page (Okies for Monarchs, www.okiesformonarchs.org).
    - <u>STRATEGY 4:</u> Habitat Restoration for Monarchs on Conservation Lands- Restore monarch butterfly habitat on both public and private conservation lands.
  - OBJECTIVE B: Develop Best (Land) Management Practices for monarch/pollinator habitat

- <u>STRATEGY 1:</u> Develop and promote Best Management Practices (BMPs) to various partners and audiences to encourage their implementation to restore, enhance and maintain m/p Habitat.
- PRIVATE AG LANDS & RANGELANDS PRIMARY GOAL: To conserve, restore and enhance rangelands, introduced-variety pastures, hay meadows, croplands (row crop farms, orchards, etc.) to support monarch butterflies and other pollinator species.
  - OBJECTIVE A: Maximize to the extent possible the utilization of agricultural lands and rangelands by monarchs and other pollinator species by encouraging the maintenance of existing monarch habitat and the creation of additional monarch habitat.
    - <u>STRATEGY 1:</u> Identify agricultural systems and best management practices that are compatible with monarch conservation.
    - <u>STRATEGY 2:</u> Create a web page for rural landowners to access all resources specific to them and register their participation in Okies for Monarchs at simple web address such as: okiesformonarchs.org/agriculture.
    - <u>STRATEGY 3:</u> Educate rural landowners and agricultural groups about monarch biology and conservation.
    - <u>STRATEGY 4:</u> Identify and Contact Landowners Identify agricultural lands and rangelands with existing habitat to be enhanced through best management practices, and lands with good potential for successful monarch restoration activities.

### **Statewide Plan Actions**

- Create lists of important plant species in each region of the state.
- Disseminate plant lists to native seed and plant producers and ask them to increase locally-sourced milkweed and nectar plant seed and plant production.
- <u>PRIMARY GOAL:</u> Increase the production of native milkweed and nectar plant seeds and plants to
  meet the numbers needed to create or restore sufficient habitat for monarchs and other pollinator
  species in all land-use sectors.
  - OBJECTIVE A: Create lists of the plant species needed in each region of the state.
    - STRATEGY 1: Convene experts, materials, reviewers needed to create lists.
      - Collect data from biological inventories to determine which host plants and nectar sources are relevant to specific regions around the state.
      - Create plant lists based using a blend of existing lists and best available local data.
      - Get approval of lists by representatives of all key stakeholder groups (row crop, rangelands, rights of way, municipal and conservation land managers)
      - Provide lists to outreach team for inclusion on web site and public docs -
  - <u>OBJECTIVE B:</u> Engage and educate seed and plant producers about the monarch conservation effort in the state and region.
    - STRATEGY 1: Develop outreach plan for engaging this group.
      - Develop a contact list of all relevant seed and plant producers in the state.
      - Contact these groups with information about the Okies for Monarchs campaign.
      - Ask producers to increase their efforts to produce locally-sourced seeds.
      - Ask producers to develop customized mixes for native range, croplands and gardens.
      - Inform outreach team of any participating producers creating customized mixes so we can include on web site and public docs (provide to outrech team
    - o STRATEGY 2: Form Seed and Plant Production Working Group and/or listserv.
      - Invite users to use this forum to share information on most efficient propagation methods.
      - Work with group to determine those species for which hand harvesting of seeds from native stands will be necessary (because seed production is not economically viable for those species
      - Work with appropriate partners to develop a list of invasive plants that are threats to native pollinators.

- Work with appropriate partners to develop fact sheets and case studies on recurring problems and solutions in monarch and pollinator habitat restoration areas.
- Share these resources with other work groups.
- OBJECTIVE C: Facilitate demand for locally sourced native milkweed and nectar plants

- Identify rights-of-way and utility managers and conduct targeted best management practice education and outreach.
- Quantify existing ROW habitat.
- Identify and address policy and cultural barriers to more monarch-friendly ROW management.
- PRIMARY GOAL: Conserve, enhance, and restore habitat on public and private rights-of-way (ROW) to support monarch butterflies and other pollinator species.
  - OBJECTIVE A: Maintain and increase (when and where feasible) available habitat for monarch butterflies and other pollinator species on both public and private ROW.
    - STRATEGY 1: Promote monarch/pollinator habitat conservation on public and private ROW.




