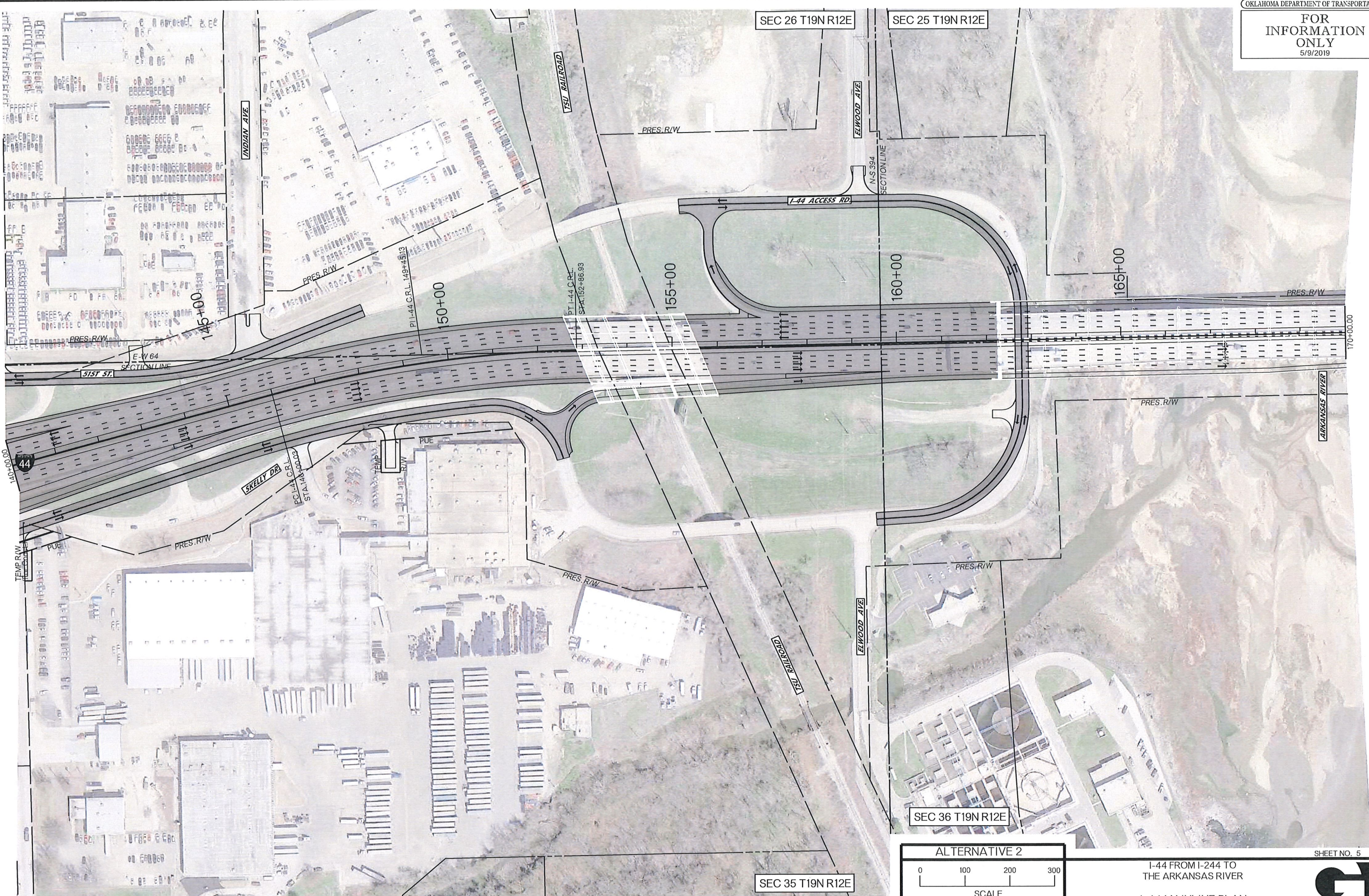

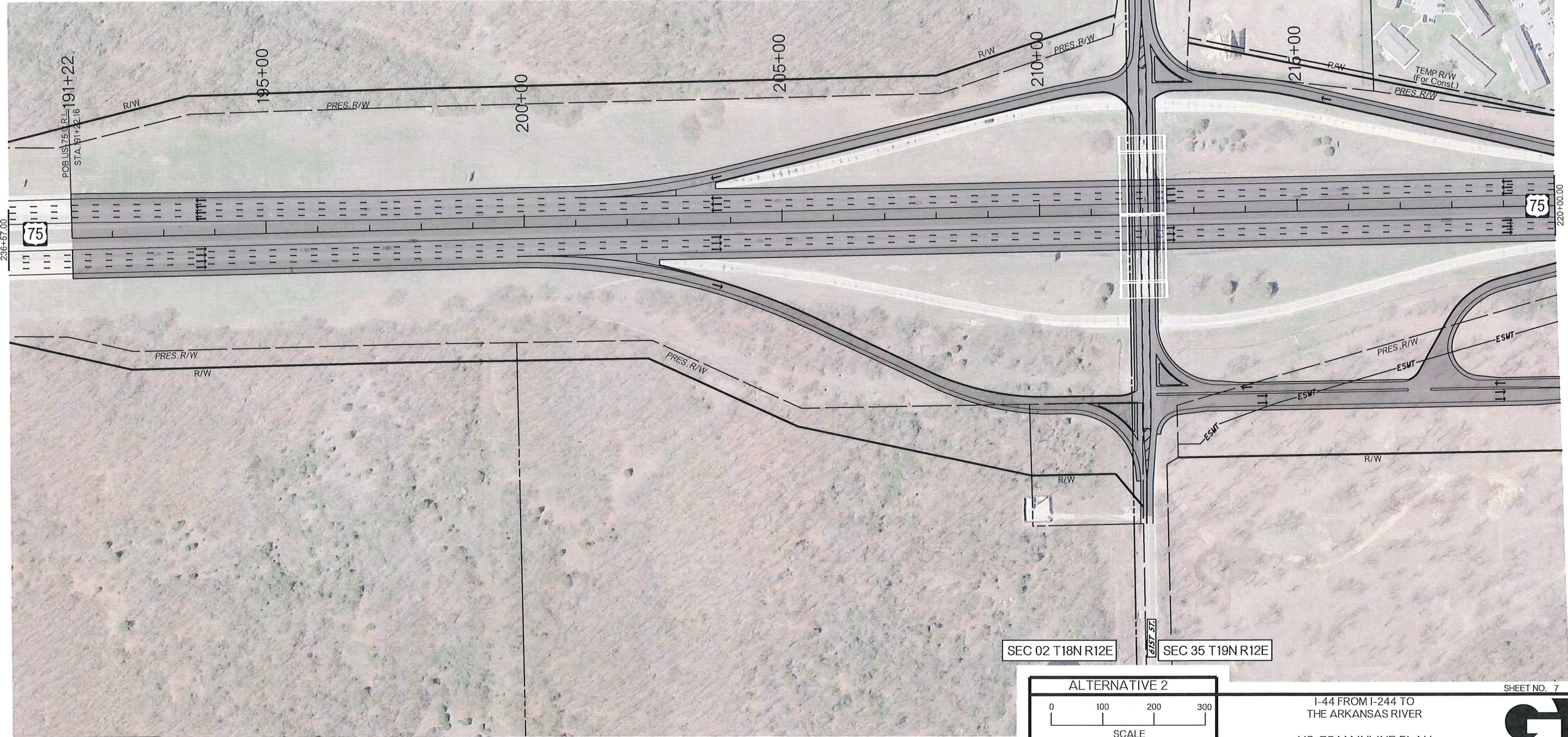

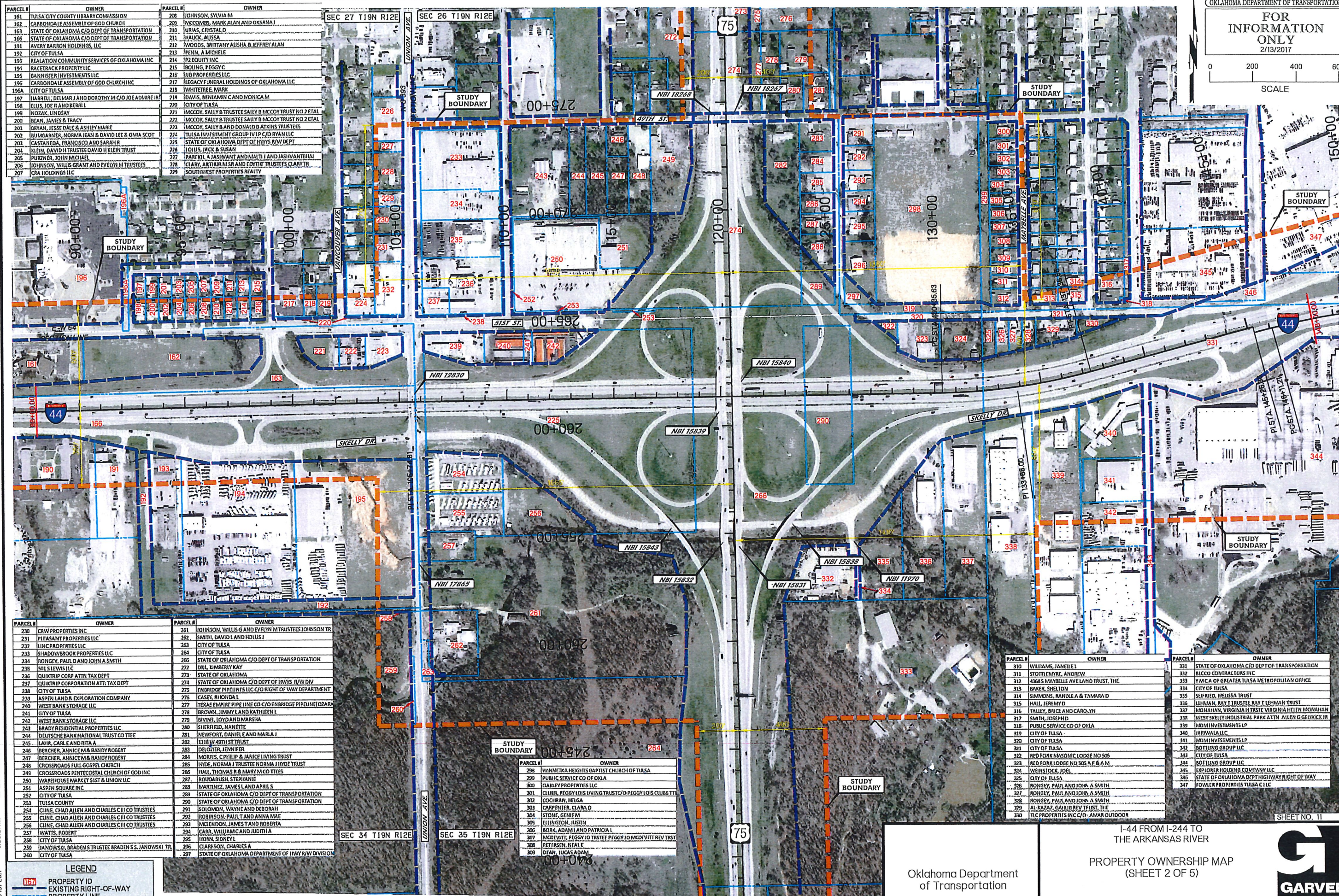

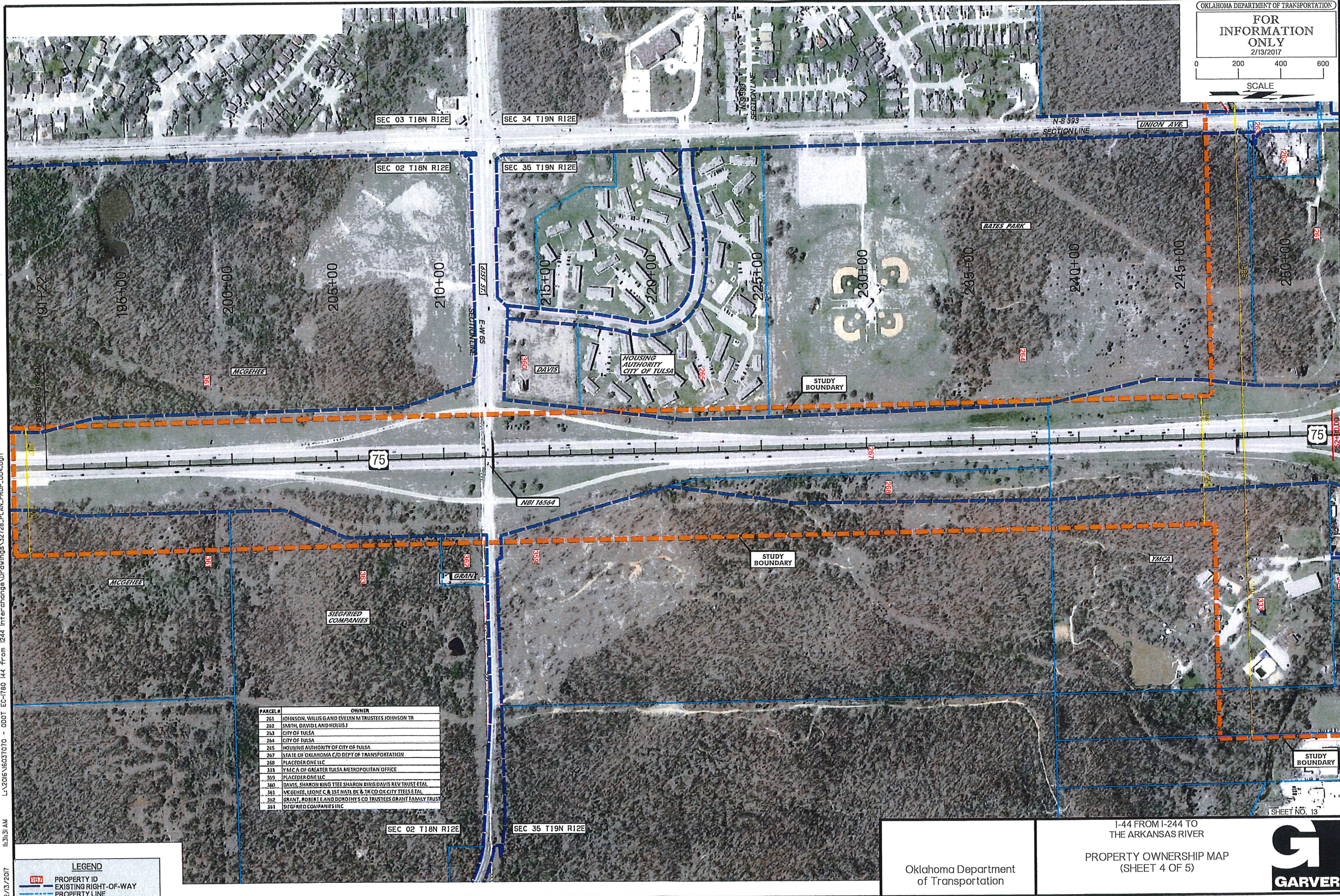

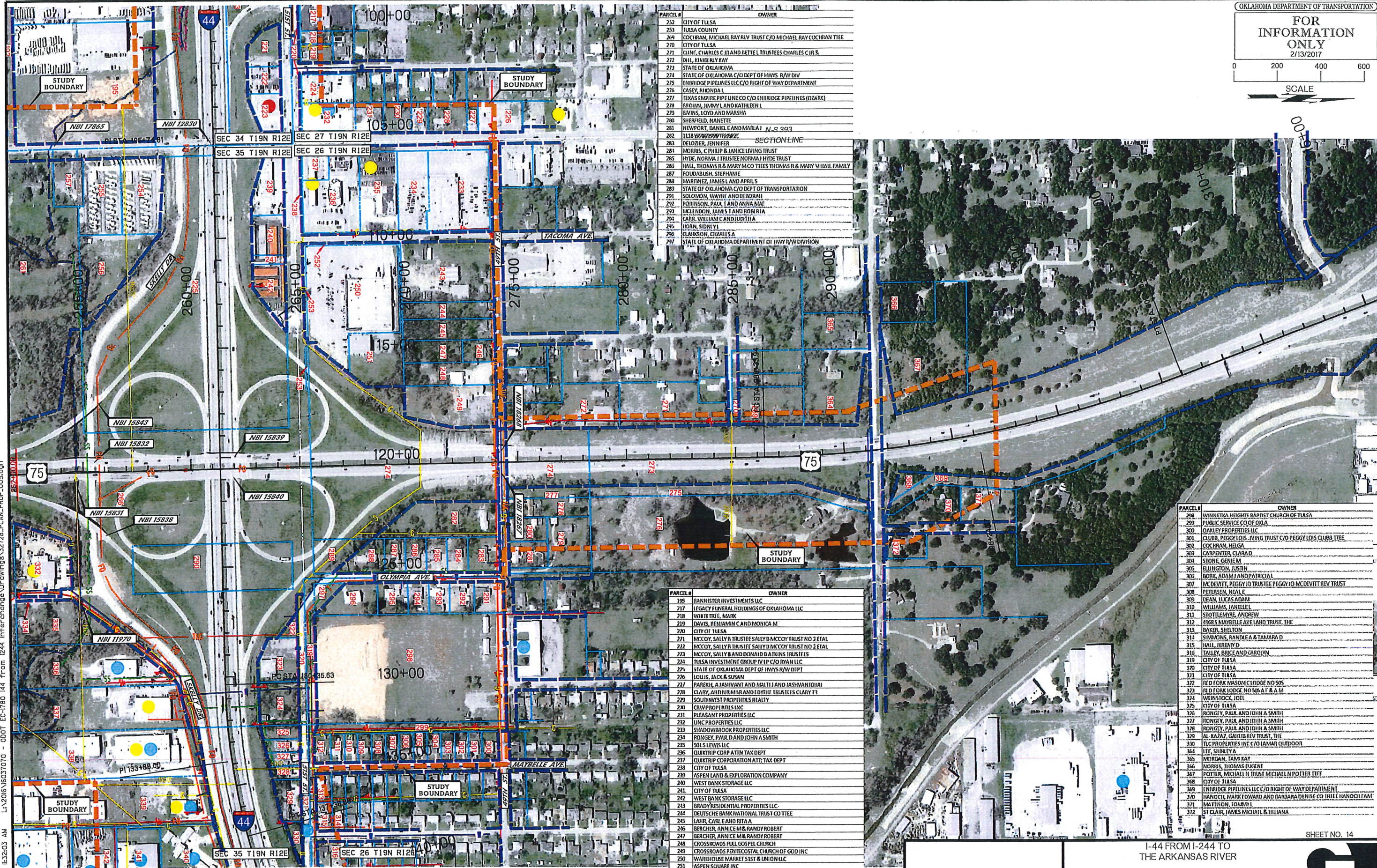
I-44 FROM I-244 TO THE ARKANSAS RIVER
