RE: PDMP Compliance Survey

Dear Medicaid Prescriber,

Section 5042 of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities Act (SUPPORT ACT), Public Law No: 115-271 (10/24/2018), requires the Centers for Medicare and Medicaid Services (CMS) to submit an annual report to Congress.

CMS is required to gather the report data from individual state Medicaid agencies. One data element the Oklahoma Health Care Authority (Medicaid) is required to submit to CMS is the percentage of prescribers who check the Oklahoma Prescription Drug Monitoring Program (PDMP) prescription drug history of a Medicaid recipient in the 7-day period *before* a controlled substance prescription is generated for the Medicaid recipient.

To report accurately, OHCA Medicaid is asking you to complete and return this anonymous survey. If your office has more than one prescriber, we ask that *each prescriber* individually complete this survey.
