


Unless stated otherwise, CHILD is defined as an individual under the age of 21.





### SoonerHealth+ Releases Request for Proposal (RFP) for Aged, Blind and Disabled (ABD) Care Coordination

OKLAHOMA CITY – The Oklahoma Office of Management and Enterprise Services (OMES) released the RFP today for SoonerHealth+, the fully capitated, statewide model of care coordination that is being developed for Oklahoma Medicaid's ABD population.

The RFP is being issued at the directive of state leadership whom approved House Bill 1566 during the 2015 session, requesting OHCA to initiate the proposal process. The legislation's intent is to provide ABD members with better access to care, improved quality and health outcomes, as well as controlled costs by utilizing a care coordination model.

OHCA follows state of Oklahoma and national procurement guidelines. Starting today, OHCA enters into a silent period, lasting until the end of this six-month procurement period. OHCA staff members will not be allowed to speak on the RFP or the process during this time.

OHCA has suspended stakeholder meetings and public presentations on SoonerHealth+ activities for the duration of the procurement period. Questions will only be accepted using the official question process that can be found in section 3.3 of the RFP under the "Submission of Questions" heading.
