
Age Breakdown of Total Enrollment



Demand exceeds expectations for women's cancer treatment program

Oklahoma City – More than 4,300 Oklahoma women have been approved for health care services through Oklahoma Cares – the Oklahoma Breast and Cervical Cancer Treatment Program (BCCTP) – since the program went into effect Jan. 1, 2005.

Of the 4,393 women who have been approved, 3,704 of them have received services through the program. According to Oklahoma Health Care Authority (OHCA) data, the top five services provided through the program have been non-emergency transportation, prescriptions and physician, outpatient and inpatient services.

Through the Oklahoma Cares program, the state provides health care benefits to women between the ages of 19 and 65 with low income and no creditable health insurance coverage for breast or cervical cancer who are screened through the Breast and Cervical Cancer Early Detection Program (BCCEDP) and found to be in need of further diagnostics or treatment for either breast or cervical abnormal findings, pre-cancerous conditions or cancer.

Before a woman can complete an application for the treatment program, she must be diagnosed or have an abnormal result from a certified screening provider under any of three BCCEDP programs: Oklahoma State Department of Health's "Take Charge!" program, the Kaw Nation of Oklahoma and the BCCEDP at Cherokee Nation. There are currently 739 providers who have signed up as certified screening providers across the state. The OSDH is currently seeking physicians, physician assistants, nurse practitioners and nurse midwives in Alfalfa, Ellis, Roger Mills, Dewey, and Washita counties to join the network of non-funded screening providers.

Once it has been determined that an applicant is eligible for health care assistance under the BCCTP, she is eligible for all SoonerCare Choice benefits during the time that she is in the program. In addition to health care coverage, women in the program can also receive care management services, transportation to receive treatment through SoonerRide, access to the SoonerCare Helpline and the after-hours Patient Advice Line. Eligible women will continue to receive services through SoonerCare until they are determined by their provider to no longer be in need of treatment for their cancer.

"We had set a goal of 2,400 applicants for the first year," said Myloe Yeager, OKDHS supervisor of the centralized eligibility unit on site at OHCA. "However, we have far surpassed that number for the overall total of women who have come through the program and we're averaging more than 366 women a month in the program."
