Dear Provider,

**Effective August 1, 2006** - Pharmacy claims will be checked for a valid Date of Birth (DOB). The DOB format is CCYYMMDD (20060801). The submitted DOB must match the member's DOB on file with OHCA. If no DOB is submitted, is submitted in an invalid format, or does not match our member file, NCPDP response 09 (M/I Birth Date) will display and the claim will be denied. The complete DOB of the member must appear in **Field 304-C4**. ## **National Provider Identifier**

The *Health Insurance Portability and Accountability Act of 1996 (HIPAA)* mandated the adoption of standard unique identifiers for health care providers. The purpose of these provisions is to improve the efficiency and effectiveness of the electronic transmission of health information. The Centers for Medicare & Medicaid Services (CMS) has developed the **National Plan and Provider Enumeration System (NPPES)** to assign these unique identifiers.

OHCA currently identifies different subparts of organizations by an alphabetical character at the end of the Provider I.D. number. NPIs will not allow these alphabetical characters. If you wish to track different subparts of your organization, you will need to apply for separate NPIs for each subpart. OHCA is encouraging all organizations to get NPIs for each subpart. If you do not get separate NPIs for subparts of your organization, there will be no way for you to track claims or revenues associated with a particular subpart. The remittance advice will include all revenues for the NPI and OHCA will not be able to separate them in any way. Once you have received your confirmation letter from CMS please fax to OHCA at (405) 530-3224. Please include your Medicaid provider identification number on the confirmation letter. No cover letter required.

### **Important Dates**

#### **NPI Information**

3/1/2007	Old OHCA provider identification numbers no longer required on claims submitted to OHCA. Claims will process with NPI only.
3/1/2007	NPI will take the place of the Medicaid Prescriber Number. Pharmacy claims will only process using the NPI in the prescriber number field.
5/23/2007	All electronic claims will be submitted with NPI only. Providers without NPI will be required to submit on paper. This could delay payment.
