**SUBJECT: 2009 EPSDT Payments & Soon To Be Sooners Drug Updates**

**Dear Provider:**

**2008 EPSDT payments will be issued on the June 17<sup>th</sup>, 2009 Remit Statements. If you have any questions please OHCA Child Health office at (405)522-7188.**

The Soon To Be Sooners (STBS) program provides coverage of pregnancy related medical services for women who would otherwise not qualify for SoonerCare benefits due to their citizenship status.

Prenatal vitamins are available for STBS members without prior authorization. Effective June 15, the following medications will also be available for STBS members without prior authorization:

- Amoxicillin Trihydrate 250mg & 500mg cap, 500mg, 775mg, & 875mg tab
- Azithromycin 1g packet, 250mg, 500mg, 600mg tab
- Cefixime 400mg tab
- Clindamycin HCL 75mg, 150mg, & 300mg cap
- Erythromycin Base 250mg, 333mg, & 500mg tab
- Erythromycin Ethylsuccinate 400mg tab
- Glyburide 1.25mg, 1.5mg, 2.5mg, 3mg, 5mg, & 6mg tab
- Insulin (Humalog<sup>®</sup>, Humulin<sup>®</sup>, Novolog<sup>®</sup>, Novulin<sup>®</sup>)
- Methyldopa 125mg, 250mg, & 500mg tab
- Metronidazole 250mg, 375mg, & 500mg tab
- Nitrofurantoin Macrocrystal 25mg, 50mg, & 100mg cap
- Penicillin V Potassium 250mg & 500mg tab

Additional medically necessary prescriptions not shown on this list may also be covered with prior authorization when the medications provide benefit to the unborn child. Please use the universal petition form (OHCA form Pharm-4) for medication prior authorization requests. These requests should include a brief description of the benefit to the unborn child in the section labeled "diagnosis/disease state." STBS members are subject to the prescription limit of six per month, with a maximum of three brand name drugs per month.
