OHCA Patient-Centered Medical Home

Melody Anthony gave an overview of SoonerCare's Patient- Centered Medical Home primary care delivery system. While the previous system was a partially capitated primary care case management program, this system utilizes a fee-for-service reimbursement model along with care coordination and incentive payments. Ms. Anthony shared a PowerPoint presentation (attachment 1) that outlines the model. Questions from the committee and the audience were encouraged.

Health Home Update

Traylor Rains spoke on the Health Home Initiative that was presented at the last meeting. A Health Home is where an individual can go to receive integrated primary and mental health care. This service is specific to those adults with SMI and children with SED. The Health Home Provider receives reimbursement for the intensive care coordination that is provided to those members.

At the last meeting, it was stated that Health Home providers would be chosen based on bids to an RFP. The State has been divided into some 21 service areas for adults and children. Bids will be accepted for a service area for children, a service area for adults, or both.

The RFP should be released within the next month. Because the RFP has not yet been released, Mr. Rains cannot speak on the requirements of the RFP. There will be a mandatory bidders meetings, which will be included in the RFP announcement. Implementation is expected to begin in January 2015. The proposed state plan amendment is posted on the OHCA website, under the proposed rules section. There are also proposed Administrative Code changes.

BH Fast Facts

Behavioral Health Fast Facts is a monthly report provided by the OHCA. The report summarizes SoonerCare enrollment, behavioral health service utilization and reimbursement. Tony Russell presented the June 2014 Fast Facts to the BHAC (attachment 2).

Telemedicine Update

There has been a lot of work going on within the OHCA Telemedicine Workgroup reviewing the current policy, examining issues and current trends, and developing a list of recommendations for the future direction of telemedicine. It is anticipated these recommendations will result in a simpler, broader telemedicine policy, and will allow for an easier management of the service delivery method. The recommendations will be presented in the form of a white paper to OHCA's CEO, and once agreed upon, will be shared with the BHAC.

New Criteria for Psychosocial Rehab

Mark Reynolds presented an overview of the new criteria for psychosocial rehab (attachment 3). There was a question from the audience regarding the PA of clients who are part of a collaboration between providers, and specific clarification on the criteria for the at risk group.

Announcement on Emergency Rule Posting

Traylor Rains provided an update on the budget reduction items that had been voted on at the previous meeting. One of those items was the limitations on Psychosocial Rehab which was implemented on August 1. ODMHSAS is currently working on the recommendation to change the prior authorization time frame for partial hospitalization from 90 days to 30 days. The next item that was recommended was limiting billable hours by rendering providers to no more than 35 hours per week. The rules that would implement those changes are currently posted on the OHCA website, under Proposed Rules. The next step in the process will be to present them to the MAC and the Board in September, and then to the Governor for an effective date of October 1.
