### **Thursday: Session 4**

Online Enrollment - Easy as 1-2-3 for SoonerCare members and partners (1:30pm – 2:30pm) The OHCA has launched www.mysoonercare.org which provides 24-hour-a-day, seven-day-a-week access to SoonerCare enrollment via an online enrollment process. Members may access SoonerCare applications through avenues most convenient to them such as home computers, community partners including the Oklahoma State Health Department, Oklahoma Department of Mental Health and Substance Abuse Services, Tribal Nations, Indian Health Service, public libraries, as well as other sites with an internet connection. In addition, the local Oklahoma Department of Human Services county office locations will remain a viable location for those members who choose to continue using the current enrollment methods. During this session, OHCA staff will demonstrate the online application process in a step-by-step walk through of the application. Preliminary data from the website and lessons learned to date for the first few weeks of operation will be presented. The session will conclude with agency partners sharing their perspectives as to how online enrollment has changed their business processes and presented opportunity to move SoonerCare enrollment into a new age of technology.

### Health Insurance Exchanges in Oklahoma – The devil is in the details (2:30pm – 3:30pm)

A central feature of national health care reform is the creation of a new exchange marketplace where members will be able to compare and purchase affordable coverage. The exchange has been described as being similar to a "Travelocity" site where members will have the ability to compare health plan benefits and prices just as they could today for different airline carriers, flight itineraries, and ticket prices. There are many considerations in the overall design of Oklahoma's exchange, some examples including governance, consumer choice, data integration among carriers and federal and state agencies, and flexibility. This session will feature a national expert who will explain the requirements for health insurance exchanges as included in the federal law, and state agency leaders who will delve into the perspectives from two agencies regarding development of a strategic plan to implement an Oklahoma exchange. You are encouraged to take part in this ground-breaking session where you will have a chance to ask questions and add to the list of considerations that may impact the Oklahoma exchange's effectiveness.
