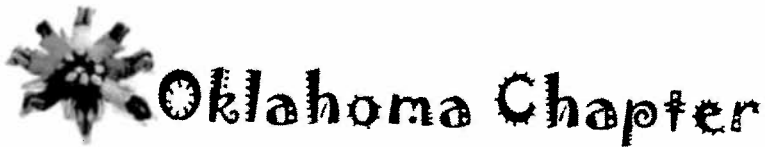



I am submitting this letter in support of your application for the Children's Health Insurance Program Reauthorization Act (CHIPRA) Quality grant. The Oklahoma State Department of Health (OSDH) supports your vision to improve the use of electronic health records, improve primary care coordination with specialists (including mental health and substance abuse) and to further develop evaluation tools utilized by Primary Care Physicians (PCPs) enabling them to conduct quality improvement activities within their practices and provide evaluation of our Medical Home Program. The collaboration you propose with Oklahoma University (OU) Tulsa Community Medicine, Oklahoma State University (OSU) Family Practice, Canadian County Health Access Network, and OU Center for Family Medicine Research, offers tremendous potential to improve the quality of care for children in the state of Oklahoma.

Your efforts to integrate all five categories available in this grant describe an overarching process for improving the way SoonerCare children receive health care. In grant category A, the Centers for Medicare and Medicaid (CMS) provide a set of core quality measures for grantees to experiment with and evaluate. The Partnership for a Healthy Canadian County Health Access Network will be taking the lead and will coordinate with providers of varying technological levels to evaluate the ability of providers to capture the core measures and promote best practices. This group will look at the best methods for collecting and analyzing the data and how these measures can translate into better quality of care.

Grant category B looks at the use of Health Information Technology (HIT) for improving care coordination and delivery. The OSU Health Access Network (HAN) will be the lead entity in this category and will explore methods of using HIT to improve the coordination of referrals, the exchange of health information and disease management capabilities. By establishing a patient registry, this category will help enhance the care management aspect of the Medical Home model and allow for better evaluation and dissemination of best practices.

Grant category C looks to address the evaluation of provider based models. By reviewing the enhancements to the medical home model, this category will be overseen by Oklahoma Health Care Authority (OHCA) and will assist with sharing findings from each of the other categories to providers and HANs alike. Category C will additionally look to address how each group improves the quality of care for children.

Grant category D is designed to help with the evaluation of a pediatric Electronic Health Records (EHR) model. Utilizing the OU/Tulsa HAN as the lead, this group will implement the pediatric EHR template designed by The Agency for Healthcare Research and Quality (AHRQ) and determine compatibility with the other initiatives being developed. This group will determine how successfully the pediatric EHR can be integrated and used for data collection, improving the use of HIT and evaluation of provider based models.

Grant category E will focus on a Continuous Quality Improvement initiative by connecting all the grant categories together. Beginning with a provider group in a single county, this concept will build on the use of practice facilitators and local learning collaborative to share best practices from all the other grant categories. By utilizing peer-to-peer forums, providers working through this initiative will have the opportunity to improve the quality of the care delivered as well as the way the care is delivered.

This endeavor forms an encompassing system of care that will improve the collection and analysis of quality measures, expand the use of HIT and EHR in care transition, and evaluate and improve the quality of children's healthcare through improved efficiency and provider involvement. This will lead to better outcomes for our children and create a template of care models that can eventually be utilized by providers statewide.

Working with the OHCA, the OSDH will continue collaboration and support efforts toward the mission, objectives, and activities outlined in the CHIPRA Quality Demonstration grant.



Oklahoma consistently ranks in the lowest quartile of the states on measures of child or adult health and many times in the lowest five among the states. As the state's Early Childhood Advisory Council we clearly recognize that Oklahoma is in need of initiatives such as this to improve the quality of health care delivered to our children so that we can improve the overall health of our state's youngest citizens.

Smart Start Oklahoma leads a coalition of 18 communities covering 51 of 77 counties in Oklahoma as well as serves as the coordinating state level agency whose mission is to increase the number of children entering kindergarten ready to learn. We address four areas of school readiness: health, mental health, family support, and early care and education opportunities. We have partnered with the Oklahoma Health Care Authority in numerous ways, most recently with a SoonerCare Campaign to increase the number of young children enrolled in the state's Medicaid program. Smart Start Oklahoma will continue this partnership and expand it to include the efforts outlined in OHCA's Quality Demonstration Grant.

OHCA will lead a broad-based collaborative effort resulting in an integrated healthcare system providing optimal quality health care to children and families in Oklahoma served by SoonerCare (Medicaid/CHIP). Systemic change will be driven by implementation and evaluation of processes and outcomes associated with use of core performance measures, enhancement of care transition and coordination, use of pediatric electronic health records and establishment of a continuous quality improvement system that will facilitate the dissemination and integration of best practices and lessons learned from grant funded activities to providers participating in the grant initiative. It is our understanding that the University of Oklahoma College of Community Health-Tulsa, Oklahoma State University College of Medicine, the University of Oklahoma College of Medicine Departments of Pediatrics as well as the Department of Family Medicine have committed to a partnership with the OHCA to perform the work delineated in this proposal. We anticipate very strong results from a partnership of this magnitude with these resources.

Quality improvements resulting from the integrated healthcare system described in this proposal can be replicated and expanded statewide and will compliment previous and current OHCA quality initiatives.

We are committed to working with OHCA to improve child health indicators in Oklahoma, and support funding of the OHCA proposal. It is an honor to be their partner.






