Rules Agenda

I. Items subject to the Administrative Procedures Act (Emergency)

A. Revising eligibility rules to disregard income from temporary census employment.

(Reference APA WF # 09-22)

B. Revising behavioral health rules to allow licensing requirements exceptions for hospitals and residential psychiatric treatment centers that are operated by the state mental hospital in accordance with Title 63 O.S. Section 1-702.

(Reference APA WF # 09-29)

C. Revising agency rules to provide clarification for providers billing for observation/treatment services. The modification provides examples of outpatient observation services that are not covered when they are provided. This change provides clarification and education to providers.

D. Revising rules to allow flexibility in the types of prenatal assessment forms that may be used instead of restricting providers to only use the American College of Obstetricians and Gynecologist (ACOG) assessment form.

E. Revising eligibility rules to comply with Senate Bill 987 of the 1st Session of the 52nd Oklahoma Legislature (2009) by increasing certain burial trust account thresholds from \$7,500 to \$10,000 effective November 1, 2009.
