


Unless stated otherwise, CHILD is defined as an individual under the age of 21.




### Age Breakdown of Total Enrollment





### **Evans rejoins OHCA**

OKLAHOMA CITY – Robert Evans, MD, has rejoined the staff of the Oklahoma Health Care Authority (OHCA) as Senior Medical Director.

He worked for the agency previously as a Medical Director from 2013 to 2015. In the interval, he worked for the Social Security Disability Determination Division as a Medical Consultant.

Evans graduated from Iowa State University with a Bachelor of Science degree in Zoology and Chemistry. He also completed coursework at that university for a Master of Science in Biology and Biochemistry. Earning a Master of Education, Adult Education and Instructional Design, from the University of Oklahoma College Of Education, Evans received his MD from the University of Oklahoma Health Sciences Center (OUHSC) where he also completed his residency in anesthesiology.
