

**AMENDMENT NINE TO THE CONTRACT BETWEEN OKLAHOMA
HEALTH CARE AUTHORITY
AND
HUMANA HEALTHY HORIZONS IN OKLAHOMA**

WHEREAS, the Oklahoma Health care Authority (OHCA) and Humana Healthy Horizons in Oklahoma (Contractor) desire to clarify, refine, and update certain Contract provisions to align with current program operations and administrative practices;

WHEREAS, the annual term of the Contract for State Fiscal Year (SFY) 2026 will expire on June 30, 2026; and

WHEREAS, the Contract has four remaining options to renew that OHCA may exercise; and

WHEREAS, the capitation rates require adjustment for SFY 2026.

NOW THEREFORE, this Amendment Nine to the Contract under Purchase Order Number 8079004727:

- (1) formally incorporates and codifies additional clarifications, refinements, and administrative updates necessary to align the Contract with current operations; and
- (2) updates capitation rates for SFY 2026.

SoonerSelect Capitation Rates

The attached Appendix B serves to provide capitation rates for the State's SoonerSelect Medical benefits for the period of July 1, 2025 through June 30, 2026.

The Oklahoma Health Care Authority (OHCA) and the Contractor mutually consent to the capitated rates provided in Appendix B, which is attached and incorporated herein, replacing the existing Appendix B insofar as it concerns capitated rates for State Fiscal Year 2026.

In the event of any conflict between the terms of this Amendment and any prior version of the Contract, the terms of this Amendment shall control. Except as expressly amended by this Amendment, all other terms and conditions of the Contract shall remain in full force and effect.

Nothing in this Amendment shall be construed to waive federal Medicaid requirements, State Plan provisions, or applicable federal regulations, all of which shall supersede Contract terms where required by law, nor shall this Amendment be interpreted to waive or limit any rights, remedies, or enforcement authority of OHCA under the Contract, applicable State law, or federal Medicaid regulations.

The parties executing this Amendment represent that they are duly authorized to bind their respective organizations to the terms of this Amendment. This Amendment may be executed in counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same instrument.

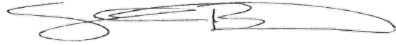
