- 1. <u>Discussion and possible action regarding CA-19-20-33</u>, request by Walter and Whitney Floyd for a Certificate of Appropriateness for exterior work at 700 NE 19th Street in the Lincoln Terrace Addition (Capitol-Lincoln Terrace East HP) of Oklahoma City:
 - **a.** Item 1, replace two rotted columns with custom painted redwood columns of matching dimensions on the front porch on the north elevation of the home.

- **b.** Item 2, repair components of the ornamental balustrade above the front porch using epoxy and sand, and replace components that are not repairable with painted redwood of matching dimensions.
- **c.** Item 3, replace deteriorated wood fascia on the front porch with painted redwood of matching dimensions.
- **d.** Item 4, install white painted aluminum guttering on the fascia of the front porch and install two downspouts.

Staff recommendation is to approve items 1 through 4, with the finding that the proposed work is designed to be compatible with the existing structure and will not have an adverse effect on the integrity and historic character of the district or the property.
