1. Announcement of filing of the meeting notice and posting of the agenda in accordance with the Open Meeting Act [Chip Mullens, Chairman]

Ms. Hicks confirmed that the meeting was in compliance.

2. Determination of quorum and call to order. [Chair]

4. Discussion and possible action regarding review and approval concepts and budgets for Art In Public Places Visitors Entrance, Ground Floor Rotunda, Ground Floor West Corridor, First Floor Rotunda, and Hall of Governors projects. [James Pickel and Dr. Alan Atkinson]

Mr. James Pickel, Chairman of the Art Standards Committee, reported on the five items presented by Dr. Atkinson. These items will need approval for the budget so that they will be ready for the Spring of 2022.

Projects for Consideration:

- Vistors Entrance and Ground Floor Lobby: Pre-Statehood & Native American History
- Ground Floor Rotunda: Coming to Oklahoma Suite
- Ground Floor West Corridor: Early Statehood and Western Heritage
- First Floor Rotunda: Oklahoma's African-American History
- Second Floor Southeast Hallway: New Hall of Governor's Lunette (Oklahoma Women)

The Oklahoma Questers donated \$4,800 to the Oklahoma Arts Council for support of the restoration of the antique frame for "Teddy Roosevelt Signing the Statehood Proclamation".

Projects total \$540, 600

The Art Standards Committee met prior to the meeting and unanimously recommended approval of the preliminary concepts and conceptual budgets for the project items listed.

# 5. Discussion and possible action to review and approve the removal and repair of sculpture from the Mansion gournds. [Duane Mass and Dr. Alan Atkinson]

Mr. Duane Mass, Chairman of the Architecture and Grounds Committee, reported that during the ice storm on October 27, 2020 that struck the Oklahoma City area, a large Hackberry tree on the grounds of the Governor's mansion fell on the sculpture titled *Love Always*. The sculpture itself had no obvious damage, however, it was pushed off of its granite base snapping the two setting pins that secured it to the base. Although there appears to be no damage to the piece, a conserverator selected for this project will double check and make sure.

The Architecture and Grounds Committee met prior to the meeting and unanimously recommended approval for the Oklahoma Arts Council to select an appropriate conservator and remove if required, the sculpture, *Love Always* from the Governor's Mansion grounds, inspect, repair, and then reinstall the piece with the two setting pins back in the same location.
