### 1. Determination of quorum and call to order:

### 3. Review of Task Force Responsibilities:

Chairwoman Merciez went over the six responsibilities of the Task Force as outlined in Executive Order 2022-14 that Governor J. Kevin Stitt signed on July 8, 2022, and filed with the Secretary of State on July 11, 2022. The Task Force is requested to submit a report to Governor Stitt, House Speaker McCall, and Senate Pro Tempore Treat by October 28, 2022.

Governor Stitt promised to sign every pro-life piece of legislation that has come across his desk. He delivered on his commitment and created the Helping Every Life and Parent Task Force represented today to carry out his pr.

## 4. Group Discussion of Opportunities:

Chairwoman Merciez stated that Oklahoma has always been a state of opportunity and feels it is vital to meet for this first time to value our culture and history and to do the same with this Task Force.

The members shared and discussed ideas, individual experiences, successes, barriers encountered, and goals they want to see accomplished through this Task Force.

The Task Force looks forward to embracing the opportunities charged before them to help in changing the lives of others for the betterment of the State and all citizens of Oklahoma.

Samantha Galloway moved that the Task Force make a recommendation in the final report to the Governor, the Pro Tempore, and the Speaker that they increase the Federal Poverty Level (FPL) related to income for pregnant mothers from 138% to 205% and extend postpartum benefits from 60 days to 12 months. Dr. Michelle Brunnabend seconded the motion. The motion passed, and the following votes were recorded:
