6. **Presentation of project update:** [Paul Haley, OMES Project Manager]

Mr. Haley gave a brief overview introduction of the process of the proposed final scope of work and the phasing plan and updated the members on the budget.

Mr. Haley updated the members on the status of tenant relocation. The Corporation Commission is in the process of relocating to the Will Rogers Building. The Arts Council will relocate to the Agriculture Building on July 14, 2023. The Election Board's permanent relocation plan is under evaluation and plans to vacate prior to the building demolition. The Department of Public Safety relocated to the State Capitol. The Office of Management and Enterprise Services relocated to the Will Rogers Building, and the American Legion has vacated the building.

Mr. Radcliffe gave the members a detailed summary of the Scope of Work for the Request for Proposals (RFP) and Programming document and work that Mass Architects has done to date.

Ms. Heather Gardner, representing Smith & Pickel, presented the final plan and gave the members a timeline design and construction overview of the three-year scope. The project summary included the building exterior, addressing the masonry, waterproofing, windows, and roofing, a two-pronged building systems approach on the major infrastructure and minor infrastructure, and a review of the historic interior scope development process and interior programming.

Ms. Gardener said the goal is to get all known tenants back into the building as soon as possible.
