5. **Presentation on Art in Public Places:** [Amber Sharples]

Ms. Sharples, Executive Director of the Oklahoma Arts Council, presented on the Art in Public Places Program (AIPP), known as the State's Percent for Art Program, and highlighted some of the successes of the public art program's past and current art projects in the Oklahoma State Capitol and on, other accomplishments made possible by the Oklahoma Arts Council through this program, and the possibilities of what can be brought to the Jim Thorpe Building for enhancement.

Ms. Sharples spoke on some of the benefits of the program and the contributing factor of art enhancements or investments made to buildings that include: Strengthens Oklahoma's brand and image, boost employee morale, contributing to a more productive work environment, encourages citizen engagement with the public agencies and its services, and increases property values.

Ms. Sharples reported on the Jim Thorpe Building Renovation Art in Public Places Project (AIPP) Budget.

6. **Presentation of Senate relocation update:** [Melissa Milburn]



Ms. Milburn gave an update on tenants in the Jim Thorpe Building that are temporarily being relocated to other spaces until renovations are completed.

The Oklahoma Arts Council selected space on the first floor of the Agriculture Building, where relocation into that building is planned for March 2023.

There has been a possible space found for storage for the Attorney General in the subbasement of the Connors Building if still needed.

The Office of Management and Enterprise Services (OMES) continues to work with the Corporation Commission on a potential solution in the Capitol Complex.

OMES has provided Troop R (DPS) with a possible layout for consideration in Suite G.7 of the Capitol building on the ground floor, east side.

The Election Board is considering moving to the Will Rogers or Connors Building basement space.

Human Capital Management (HCM) plans to use alternative training spaces.

The American Legion is looking for other space. OMES has sent them a lease termination effective March 1, 2023.

7. **Presentation of Design Build Update:** [Melissa Milburn – Mass Architects]

Ms. Milburn reported that OMES executed the AE-1 contract and has begun reviewing Mass Architects'(MA) draft for the Request for Quote (RFQ). OMES anticipates the final review and finalization of the RFQ and will return to Mass Architects this week for them to issue the RFQ on January 15, 2023.

Ms. Milburn informed the LIDAR scanning of the building would be completed this week, and Mass Architects has a masonry expert reviewing the structure today.
