5. Discussion and possible action to approve the transfer of state-owned property:

OMES Requests the approval of the Long-Range Capital Planning Commission for the Transfer of the Following Property:

- 1. Department of Commerce, transfer of a closed portion of Stiles Avenue, located in Oklahoma City, Oklahoma County, Oklahoma
 - a. The property is owned by the Department of Commerce
 - b. The property consists of a closed portion of Stiles Avenue and is adjacent on the west o the Department of Commerce property
 - c. The Department of Commerce will transfer ownership by quitclaim deed to the Oklahoma City Urban Renewal Authority (OCURA)
 - d. The transfer will not generate any proceeds.

Travis Mason moved to approve the transfer of the Department of Commerce, Stiles Avenue portion. Josh Cruzan seconded the motion. The motion passed, and the following votes were recorded:

- **2.** Department of Corrections, former William S. Key Correctional Center, transfer of land and buildings, located in Fort Supply, Woodward County, Oklahoma.
 - a. The property is owned by the State of Oklahoma Department of Corrections.
 - b. The property is currently vacant.
 - c. OMES will transfer the property in three parcels.
 - i. Parcel A consisting of 3,146 acres MOL of land and buildings, will be transferred to a multi-county trust known as the Fort Supply Preservation Authority.
 - ii. Parcel B consisting of historical buildings on 13.78 acres MOL, together with access for ingress and egress, will be transferred to the Oklahoma Historical Society; and
 - iii. Parcel C consisting of 40 acres MOL of agricultural land, ancillary buildings, and 3 residential properties, will be transferred to the Fort Supply Public School District.
 - d. OMES will transfer the property on behalf of the State of Oklahoma, ex rel. Department of Corrections by quitclaim deeds.
 - e. The transfers will not generate any proceeds.



Travis Mason moved to approve the transfer of the Department of Corrections land and buildings. Josh Cruzan seconded the motion. The motion passed, and the following votes were recorded:

- **3.** Oklahoma Military Department Vacant Land located South and West of NE Grand Boulevard, Oklahoma City, Oklahoma County, Oklahoma
 - a. The property is owned by the Oklahoma Military Department (OMD).
 - b. The property consists of 5.45 acres MOL of vacant land.
 - c. The OMD will transfer the property by quitclaim deed to the Oklahoma County Public Buildings Authority, a Public Trust.
 - d. The transfer will not generate any proceeds.
