Board on Legislative Compensation constitutional reference

Okla. Const. art. V, § 21:

- "... Board shall each two years review the compensation paid to the members of the Legislature and shall be empowered to change such compensation; such change to become effective on the fifteenth day following the succeeding general election."
- Appointing authority:
 - Governor five members.
 - President Pro Tempore of the Senate two members.
 - Speaker of the House of Representatives two members.



Board on Legislative Compensation statutory reference

74 O.S. § 291.2 sets the meeting date and time and establishes the term limits for the board members.

- "... third Tuesday of October in every odd-numbered year at nine o'clock a.m."
- "... the Board shall review the compensation paid to members of the State Legislature and, if necessary, change the compensation."
- "... [may] hold such additional meetings as are necessary to carry out its official duties."
- "Any change in legislative compensation shall be made by the Board no later than the third Tuesday of November in said odd-numbered year."


2025 regional legislator pay assumptions

- Most states provide legislators with an allowance for office supplies. This amount is not included.
- Salary does not include benefit allowances or retirement contributions.
- Session-length calculations are based on the dates on which each state legislature convened and adjourned in 2025, and they assume a four-day workweek (Monday through Thursday) excluding holidays and recesses; session limits used when applicable; special sessions not included.

Regional data highlights

Oklahoma	Regional comparison (higher)
Only one per diem rate: \$196/day	Colorado's per diem for those beyond 50 miles of the State Capitol is \$237/day; the per diem for those within 50 miles of the State Capitol is \$45/day.



2025 regional legislator retirement comparison

 Oklahoma OPERS, elected on or after Nov. 1, 2011, 3.5% with 2% computation factor OPERS, elected prior to Nov. 1, 2011, up to 10.0% with 4.0% computation factor Pathfinder, elected after Nov. 1, 2015, up to 7.0% or above employee contribution and 7.0% employer match 	= up to 5.5% of salary= up to 14% of salary= 14% of salary and up
Arkansas	= 5.25% of salary
Colorado	= 11% of salary
Kansas	= 6% of salary (optional)
Louisiana	= 0%
Missouri	= No employee contribution, or 4% after Jan.1, 2011

Texas	= 9.5% of salary (optional)



Additional notes

- New Mexico does not pay a salary.
- Oklahoma's salary remained the same at \$47,500.
- Texas meets biennially for a maximum of 140 regular session days; members are paid \$600/month, or \$7,200/year.
