

**MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE OKLAHOMA  
DEPARTMENT OF MENTAL HEALTH AND SUBSTANCE ABUSE SERVICES AND  
THE OFFICE OF MANAGEMENT AND ENTERPRISE SERVICES PURSUANT TO 62  
O.S. §9010.5(D)**

**I. PURPOSE**

- A) This agreement establishes a payment process for reimbursement through payment from the Office of Management and Enterprise Services (“OMES”) on behalf of the Oklahoma Department of Mental Health and Substance Abuse Services (“ODMHSAS”) in order to enact the provisions of the Pay for Success Act, 62 O.S. §9010.1 et. seq.
- B) Payment process established in HB 2670 Pay for Success contract with PIVOT INC.to access funds for payment to PIVOT INC.
- C) ODMHSAS will provide notification to OMES for payment for delivery of certain targets and outcomes of participants in the program, more specifically defined in the:
  - 1. Attachment A –Statement of Work;
  - 2. Attachment B – Renewal PO for FY-2025; and
  - 3. Attachment C – Contract.

This Statement of Work will also be incorporated into the contract for services between ODMHSAS and PIVOT INC.

**II. DURATION**

This MOU shall be in effect upon the signature of both parties for a period of one year beginning April 16, 2025, and ending on June 30, 2025, with four one (1) year options to renew. The renewal period for this MOU shall begin on July 1, 2025. The renewal needs to be in place prior to the end of each year’s contracted period. In addition, each year is dependent upon the availability of earmarked funds for that contracted year. This agreement remains unchanged unless modified in writing and acknowledged by both parties.

**III. FUNDING**

ODMHSAS will utilize funds available in ODMHSAS’ Pay for Success Innovation Fund which is maintained by OMES to establish the encumbrance and direct OMES to make success payments to PIVOT INC.in accordance with the terms of the contract entered between ODMHSAS and PIVOT INC. A Purchase Order will be created by OMES, who will then pay the amount owed out of the remaining earmarked funds of \$152,835.00 for this program. In order for OMES to make a Success Payment to PIVOT INC., an invoice and proof of delivery of the targets and outcomes of participants in the program will be provided to OMES Accounts Payable by PIVOT INC.

**IV. SIGNATURES**

This MOU will be re-evaluated by OMES and the ODMHSAS as needed. This MOU will become effective upon execution of the signatures by the parties.
