

# REQUIRED NOTICE

THE OKLAHOMA REAL ESTATE COMMISSION (OREC) PARTICIPATES IN THE SYSTEMATIC ALIEN VERIFICATION **FOR ENTITLEMENTS** (SAVE) PROGRAM. WHICH INTERGOVERNMENTAL **INFORMATION-SHARING** INITIATIVE DESIGNED AID IN TO DETERMINING NON-CITIZENS APPLICANT'S IMMIGRATION STATUS (LAWFUL PRESENCE), AND THEREBY ENSURING ONLY US CITIZENS AND ELIGIBLE NON-CITIZENS RECEIVE GOVERNMENT BENEFITS. SUCH AS LICENSES. OREC MAY ONLY ISSUE LICENSES TO US CITIZENS OR QUALIFIED ALIENS (NON-US CITIZENS) WHO PRESENT VALID DOCUMENTARY **EVIDENCE OF ONE (1) OF THE FOLLOWING:**

- Certificate of Citizenship (N-560 or N-561)
- US Citizenship ID Card (I-197)
- American Indian Card classification code "KIC"

# **REQUIRED NOTICE**

ANY APPLICANT CONVICTED OF ANY CRIMES LISTED BELOW SHALL NOT BE ELIGIBLE TO OBTAIN A REAL ESTATE LICENSE WITHIN TWENTY (20) YEARS OF THE COMPLETION OF ANY CRIMINAL SENTENCE, INCLUDING PAROLE AND PROBATION, PERSONS CONVICTED OF:

- 1.FIRST DEGREE MURDER AS DEFINED IN SECTION 701.7 OF THIS TITLE;
- 2.SECOND DEGREE MURDER AS DEFINED BY SECTION 701.8 OF THIS TITLE;
- 3. MANSLAUGHTER IN THE FIRST DEGREE AS DEFINED BY SECTION 711 OF THIS TITLE;
- 4.POISONING WITH INTENT TO KILL AS DEFINED BY SECTION 651 OF THIS TITLE;
- 5.SHOOTING WITH INTENT TO KILL, USE OF A VEHICLE TO FACILITATE USE OF A FIREARM, CROSSBOW OR OTHER WEAPON, ASSAULT, BATTERY, OR ASSAULT AND BATTERY WITH A DEADLY WEAPON OR BY OTHER MEANS LIKELY TO PRODUCE DEATH OR GREAT BODILY HARM, AS PROVIDED FOR IN SECTION 652 OF THIS TITLE:
- 6.ASSAULT WITH INTENT TO KILL AS PROVIDED FOR IN SECTION 653 OF THIS TITLE;
- 7. CONJOINT ROBBERY AS DEFINED BY SECTION 800 OF THIS TITLE;
- 8. ROBBERY WITH A DANGEROUS WEAPON AS DEFINED IN SECTION 801 OF THIS TITLE;
- 9. FIRST DEGREE ROBBERY AS DEFINED IN SECTION 797 OF THIS TITLE;

APPLICANTS CONVICTED OF A FELONY CRIME THAT SUBSTANTIALLY RELATES TO THE OCCUPATION OF A REAL ESTATE AGENT AND POSES A REASONABLE THREAT TO PUBLIC SAFETY, INCLUDING CRIMES INVOLVING FRAUD, EMBEZZLEMENT, FORGERY, EXTORTION, CONSPIRACY TO DEFRAUD, OR SIMILAR OFFENSES ARE INELIGIBLE FOR A REAL ESTATE LICENSE FOR 10 YEARS AFTER COMPLETING THEIR SENTENCE.

APPLICANTS CONVICTED OF OTHER FELONIES ARE INELIGIBLE FOR A REAL ESTATE LICENSE FOR 5 YEARS AFTER COMPLETING THEIR SENTENCE.

FOR CLARIFICATION, PLEASE CONTACT THE COMMISSION THE COMMISSION WILL ALLOW THE APPLICANT TO SEEK PRE-APPROVAL PRIOR TO ENROLLING IN A PRE-LICENSE COURSE.
