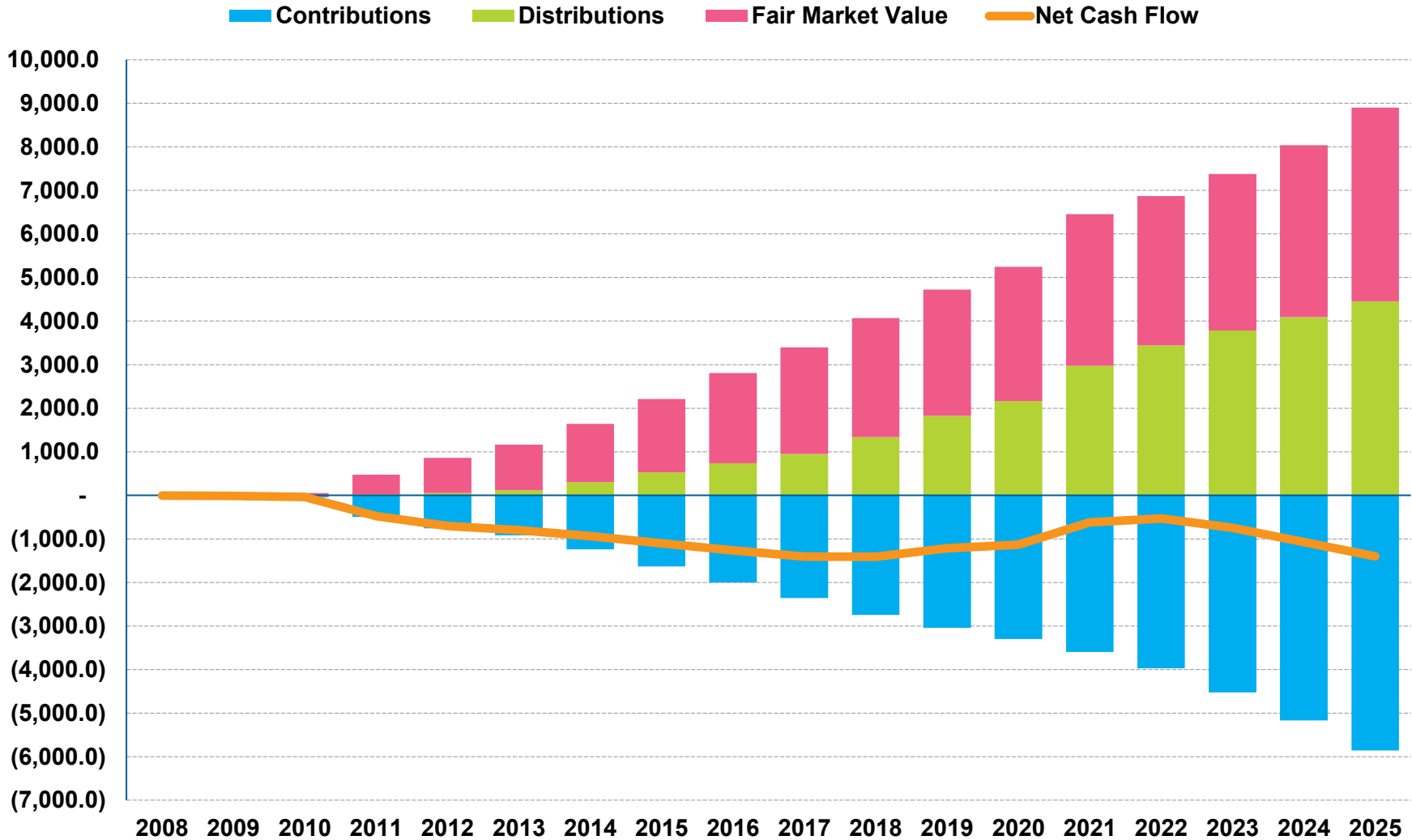

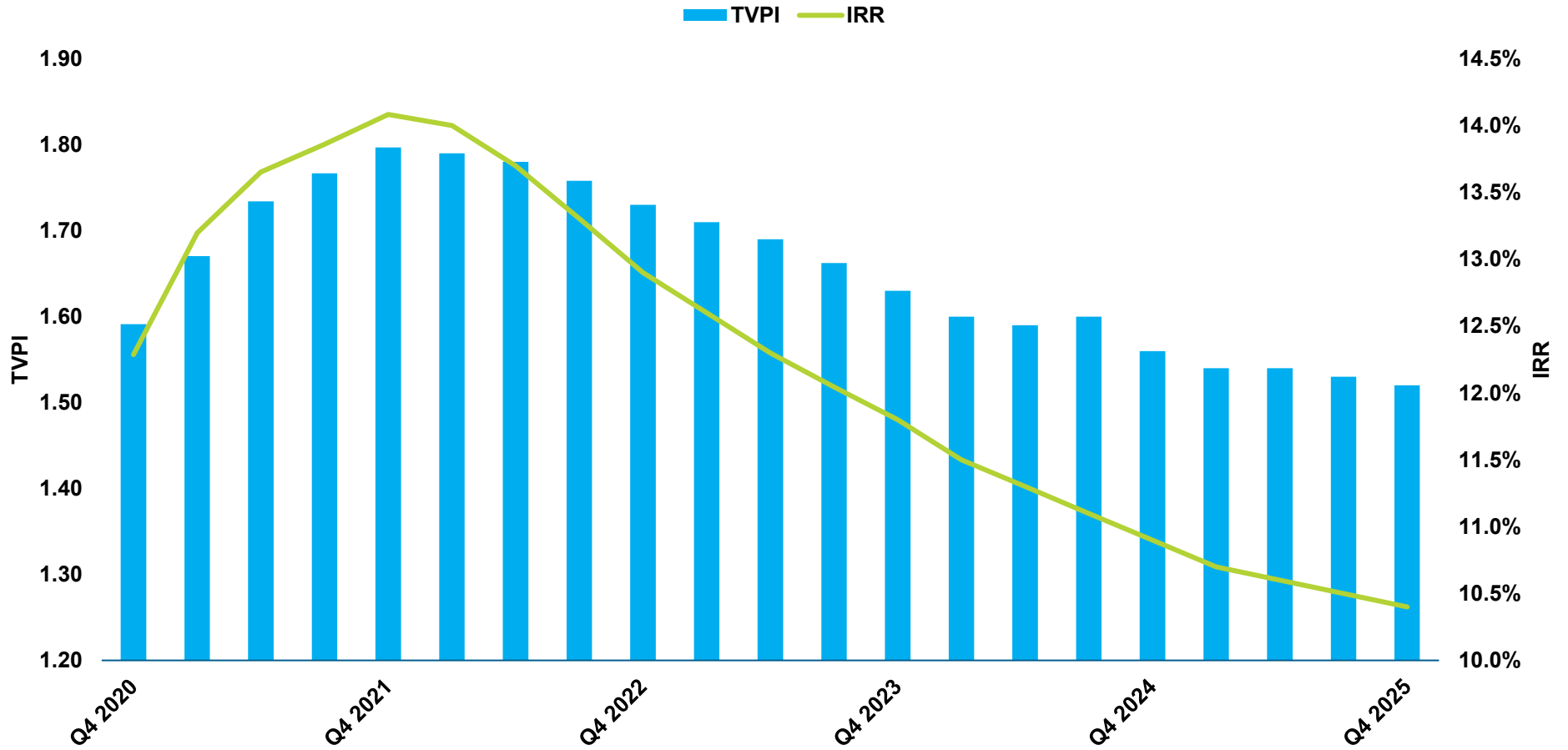

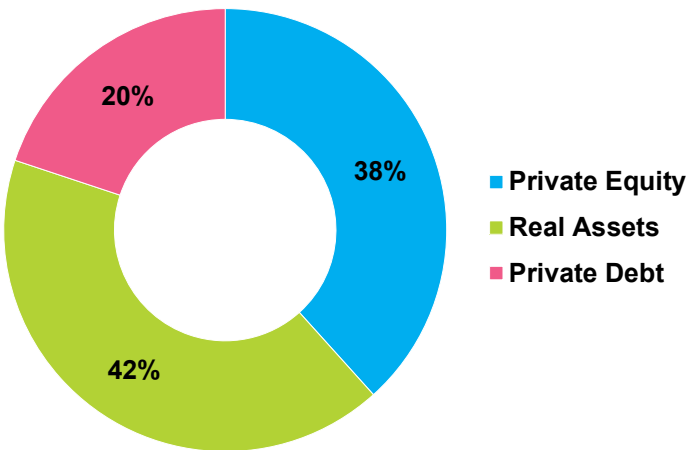
Total Program - Net Cash Flows (\$ millions)



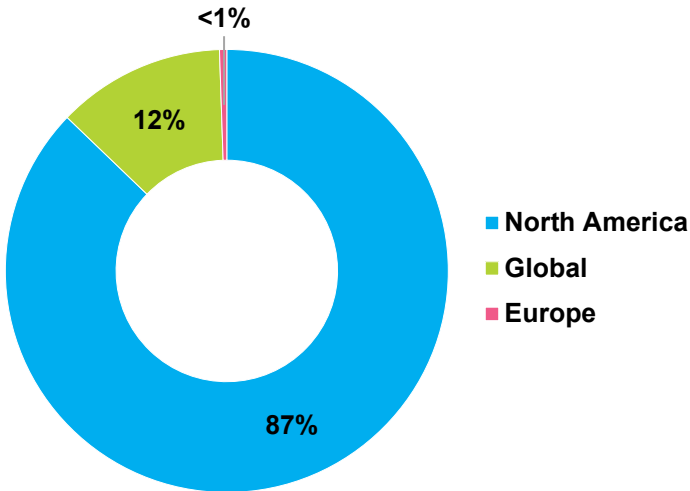
Since Inception Performance Over Time



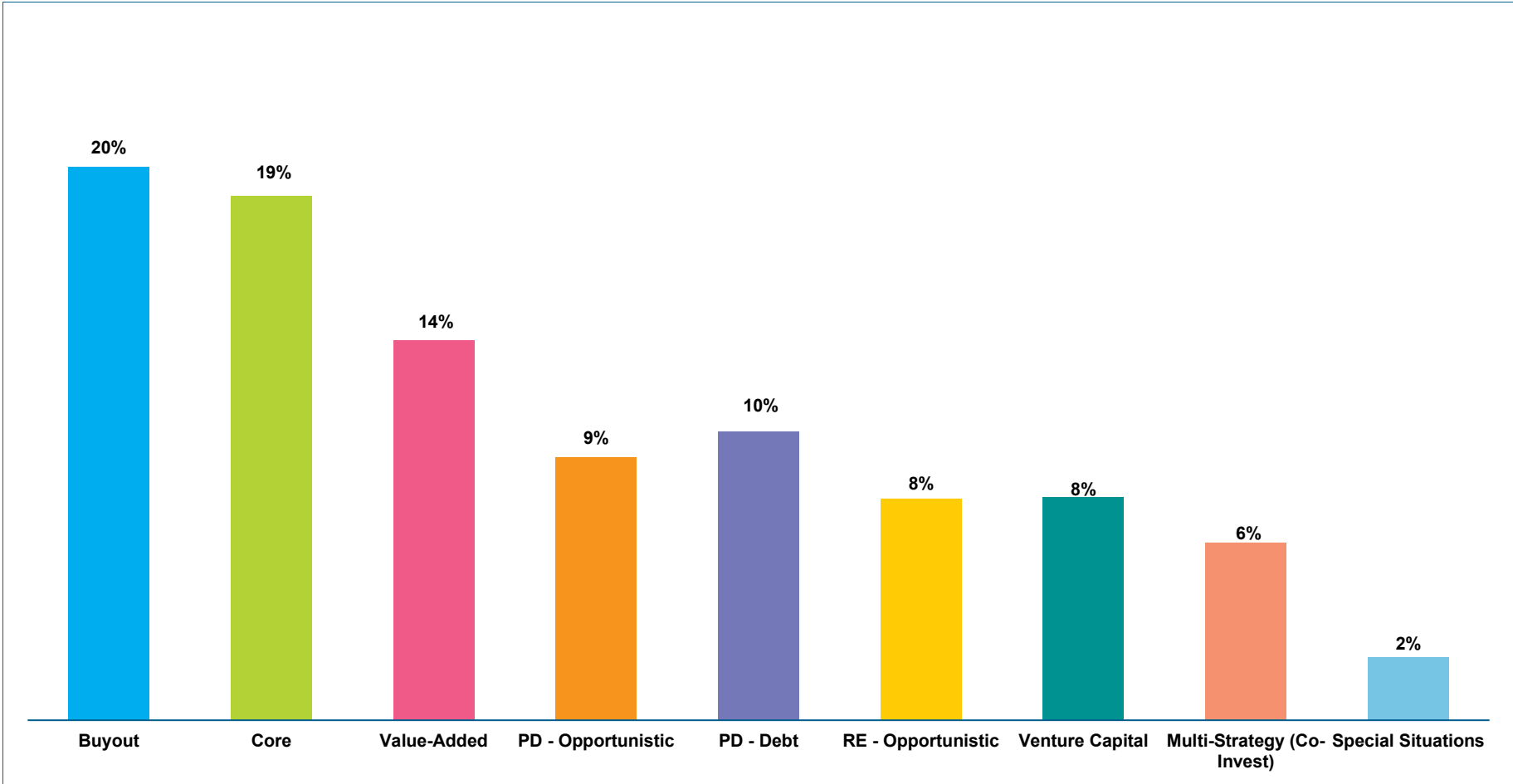
Diversification by Asset Class – Reported Fair Value



Diversification by Geography – Reported Fair Value

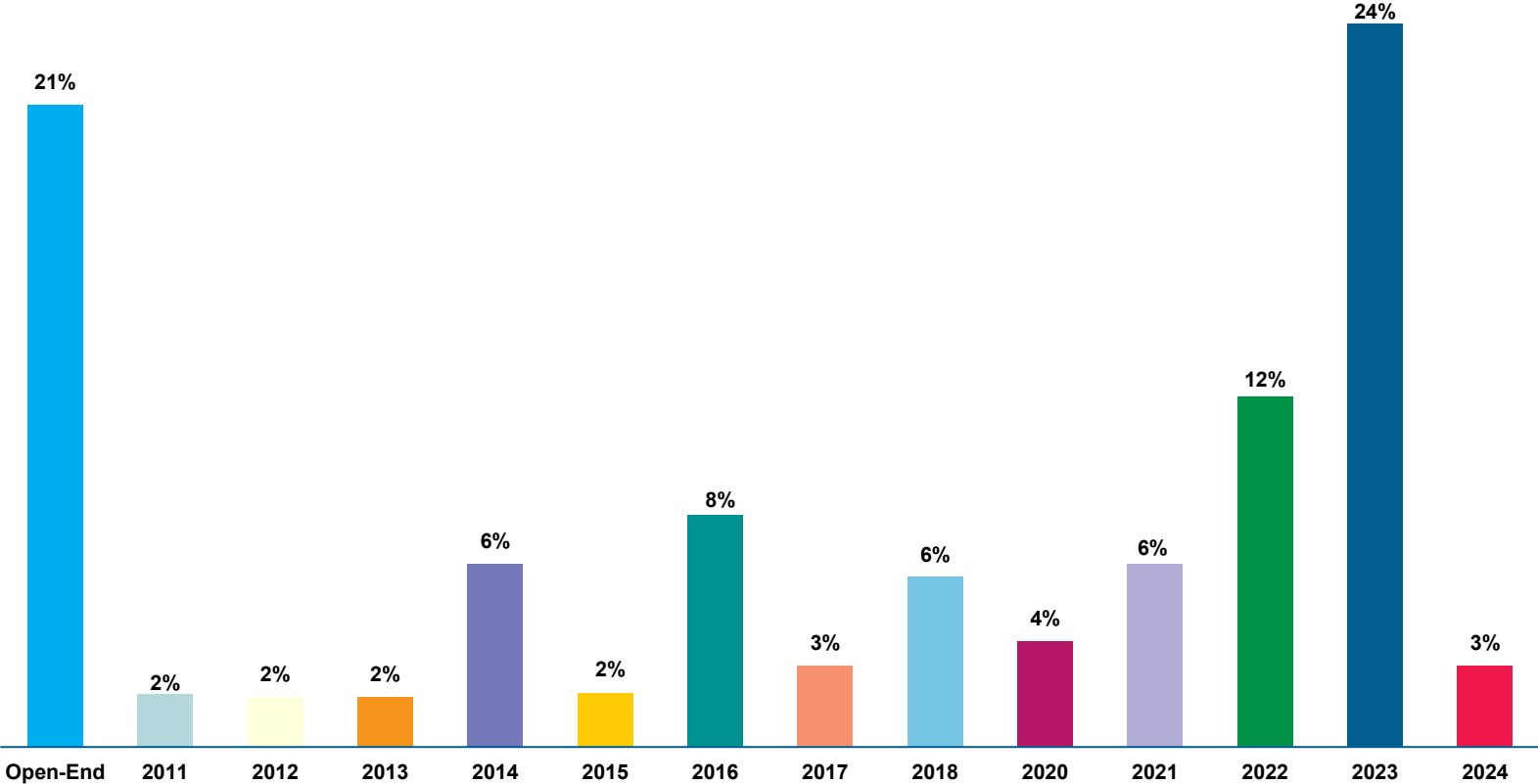


Diversification by Investment Strategy – Reported Fair Value*

Diversification by Vintage Year – Reported Fair Value¹

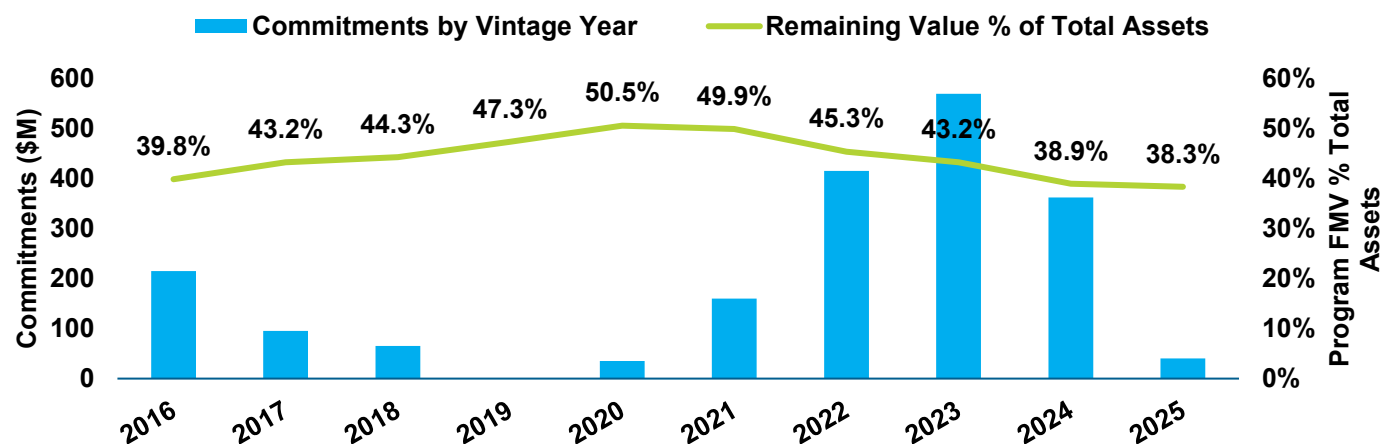

Introduction

As of December 31, 2025, OTRS had committed \$3,353.3 million to 101 partnerships (64 Buyout, 13 Venture Capital, 7 Special Situations, 4 Oil & Gas, 3 Private Debt, 3 Distressed, 2 Secondary, 3 Growth Equity, and 2 Multi-Strategy Co-investment). The reported fair value of the aggregate Private Equity Program was \$1,704.5 million at the end of the fourth quarter.



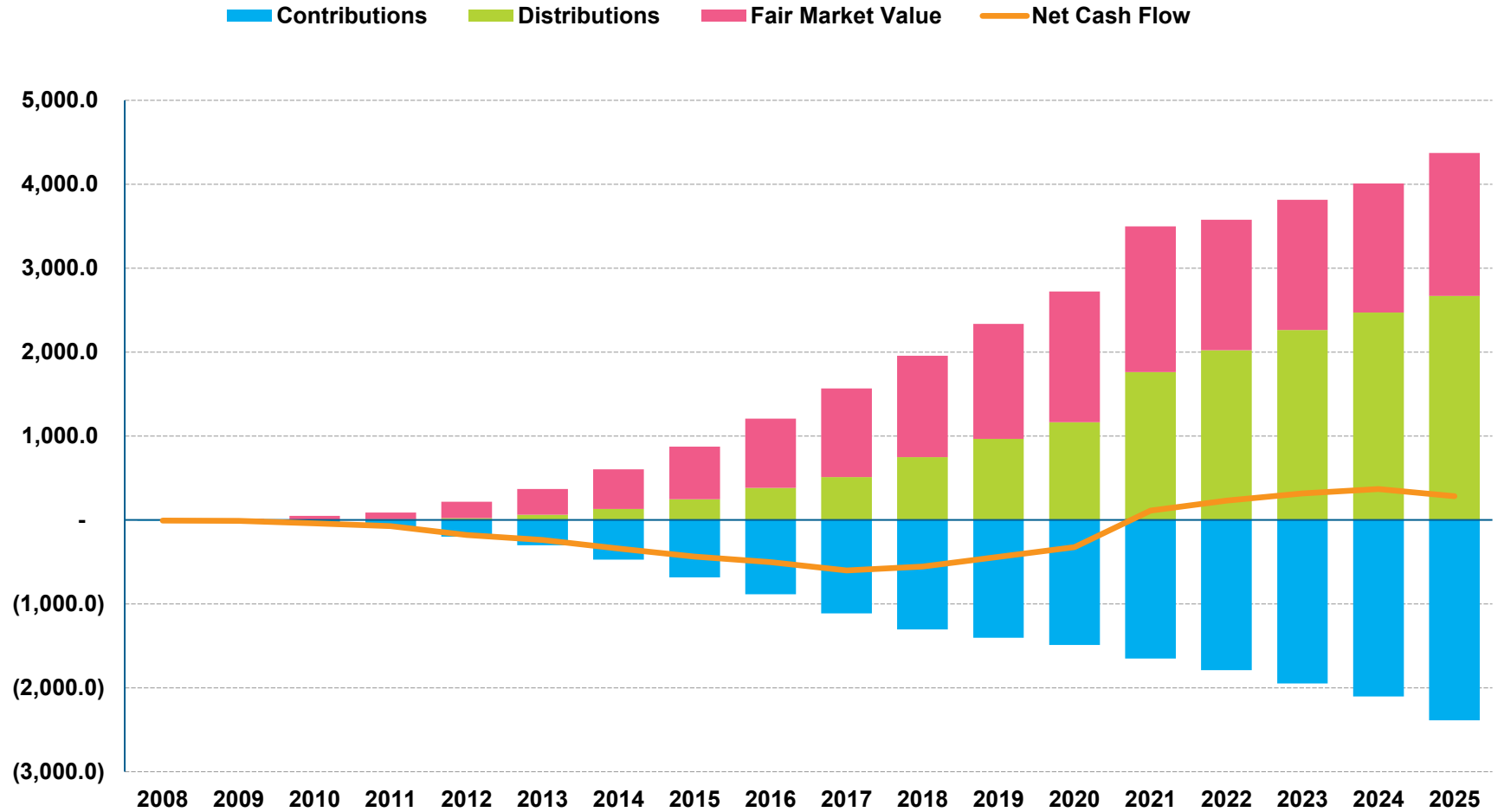

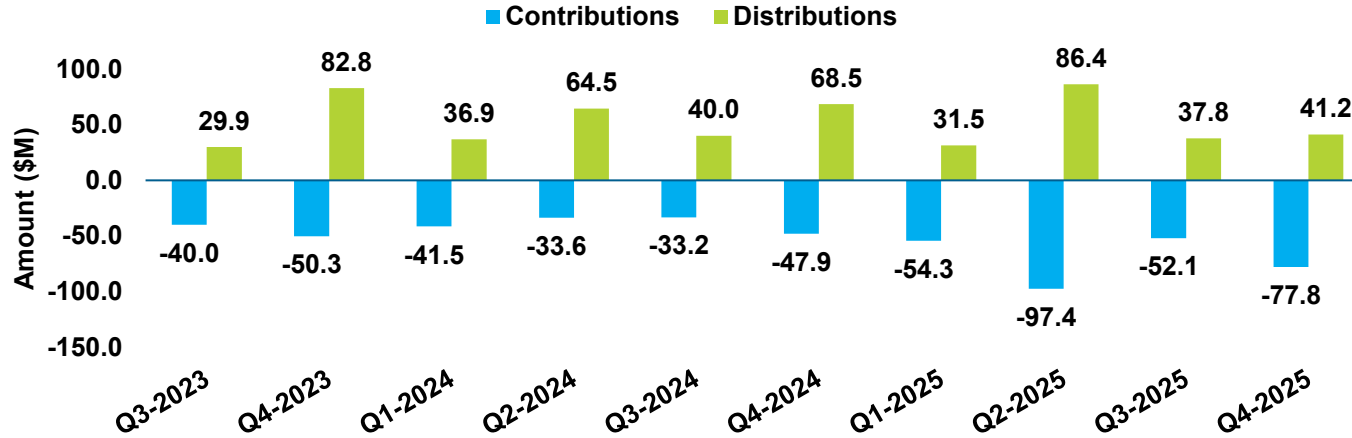

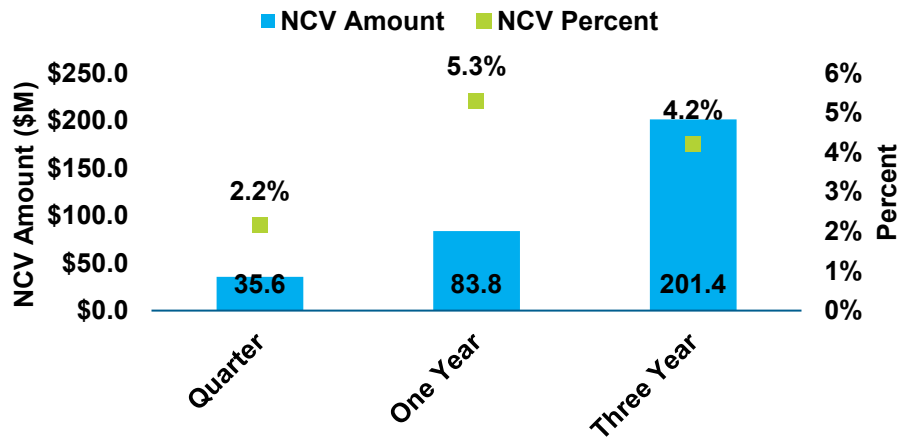

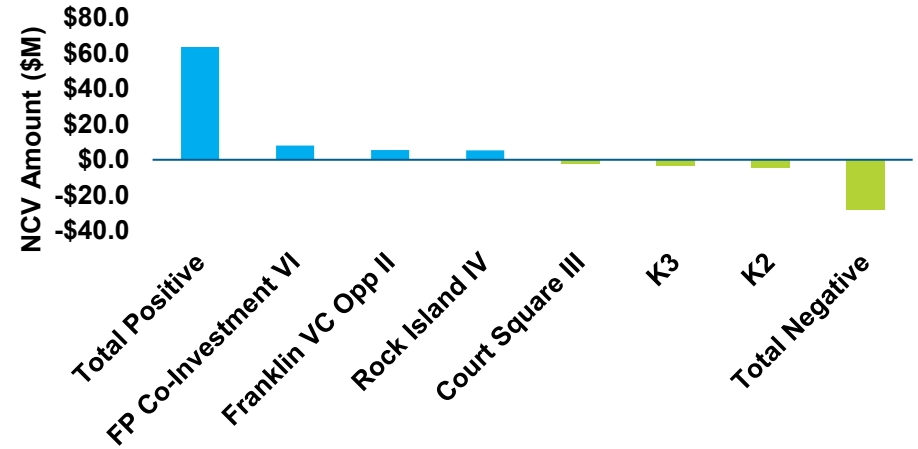
Since Inception Performance Over Time

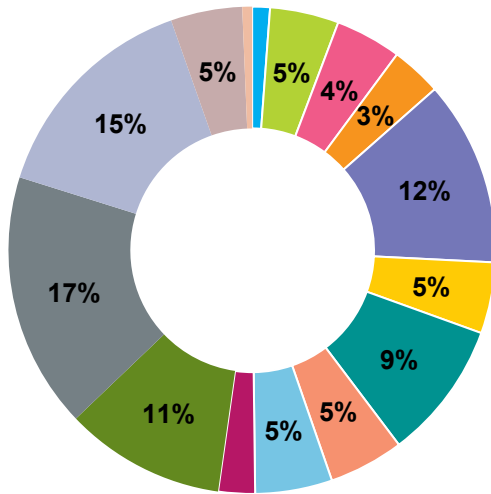

Percent of FMV

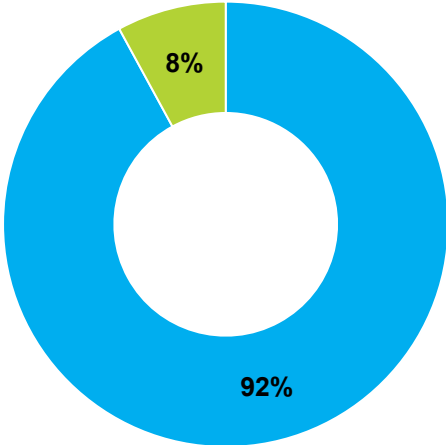


Percent of Exposure



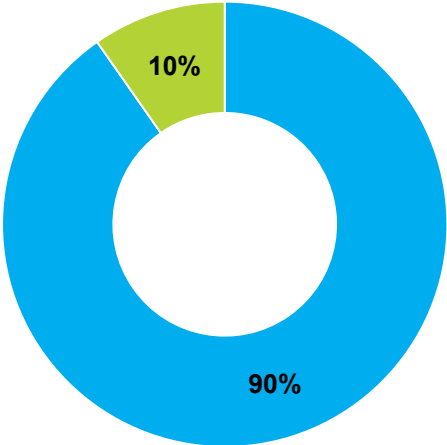
By Geographic Focus

Percent of FMV



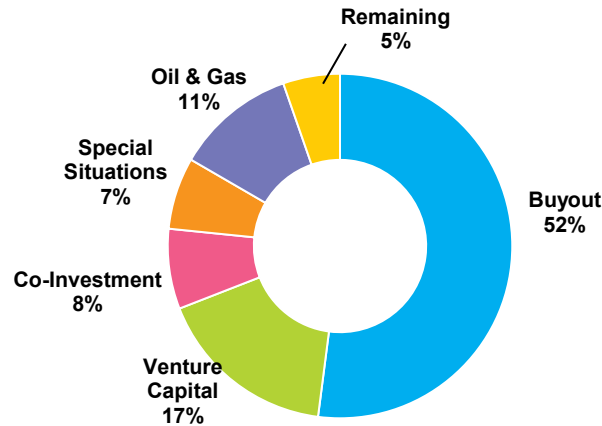

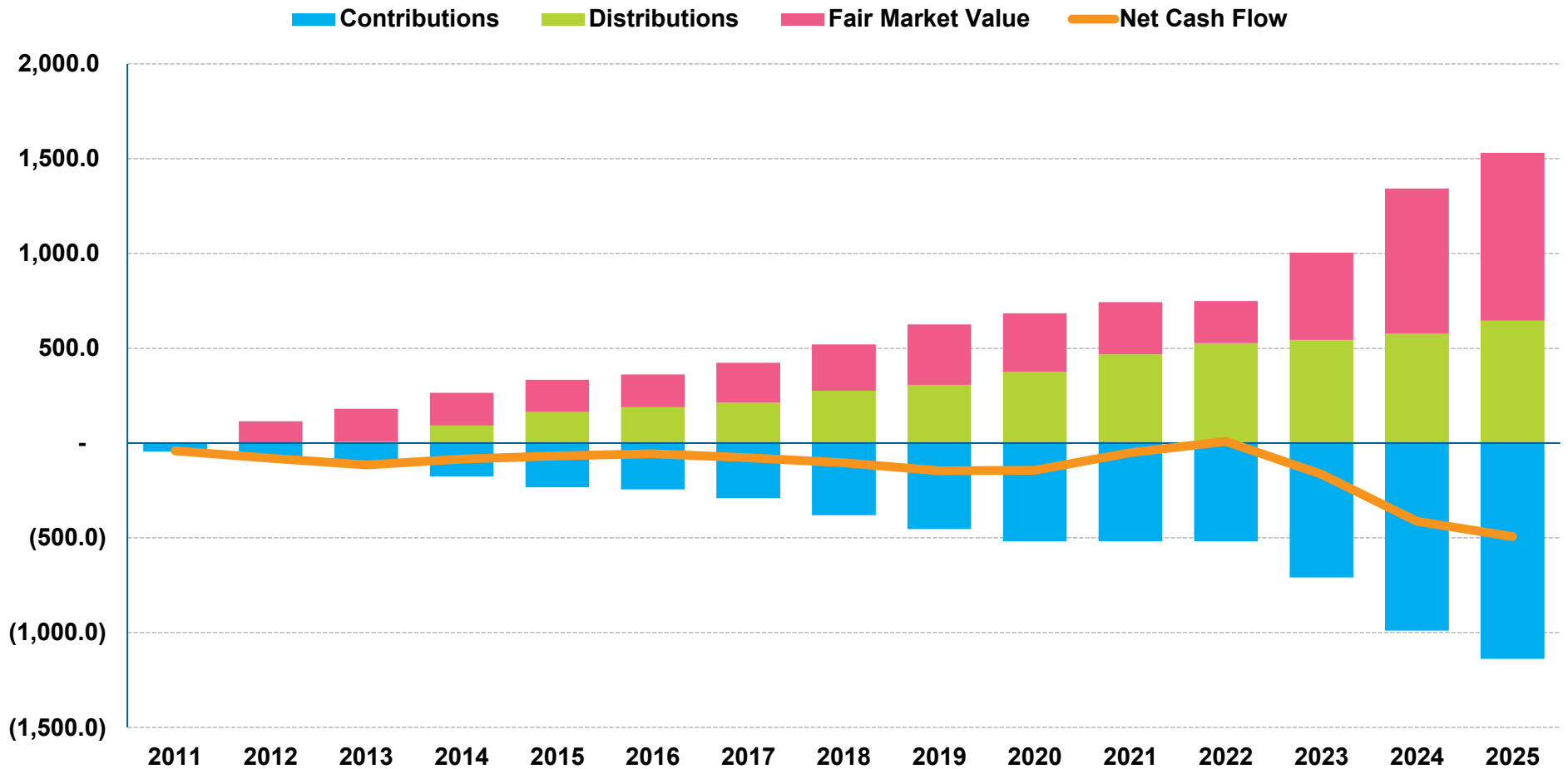

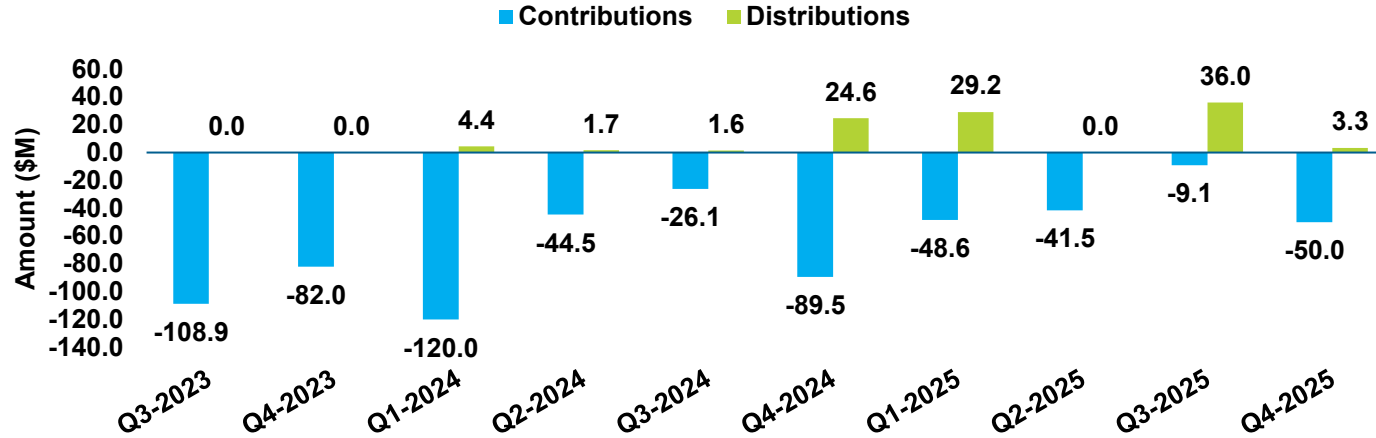

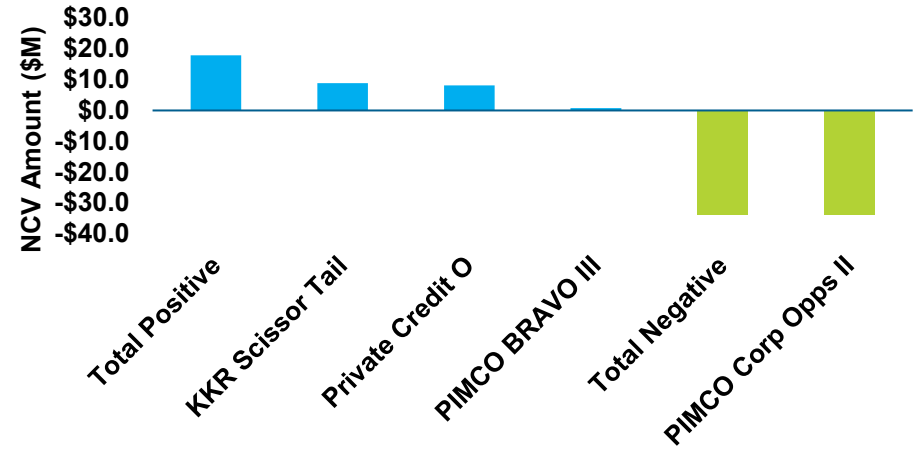
Since Inception Performance Over Time

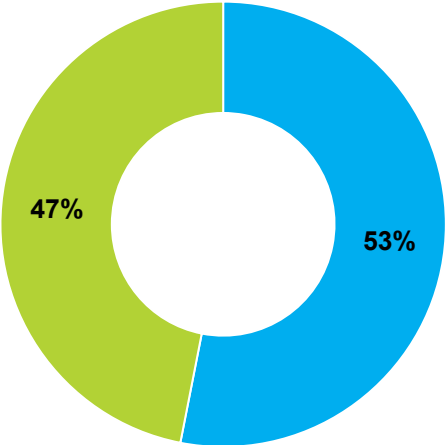

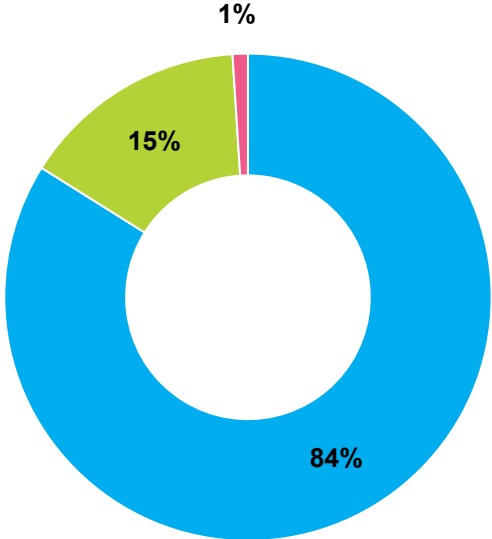

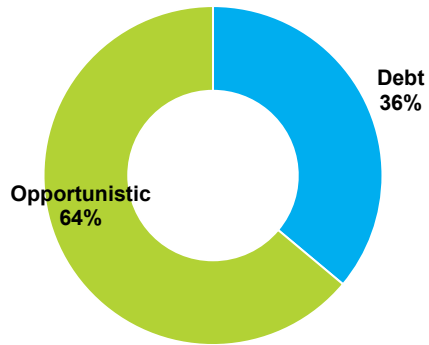

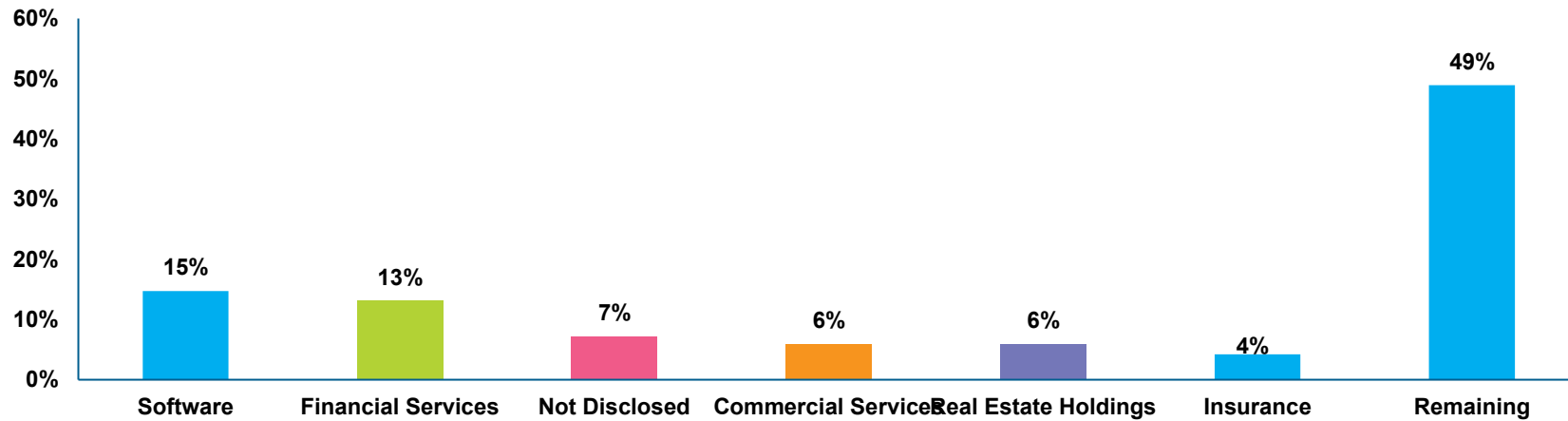

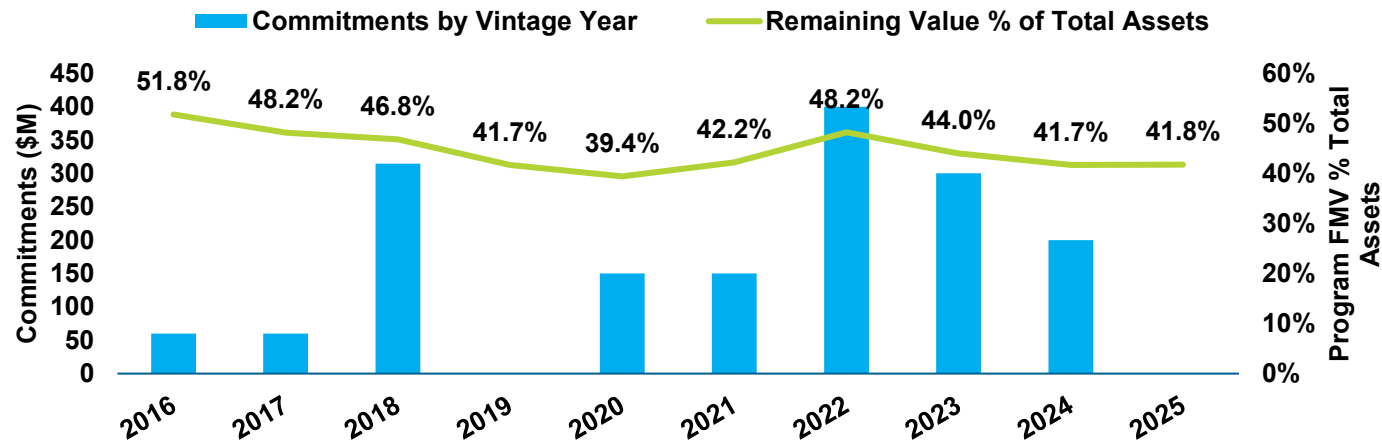

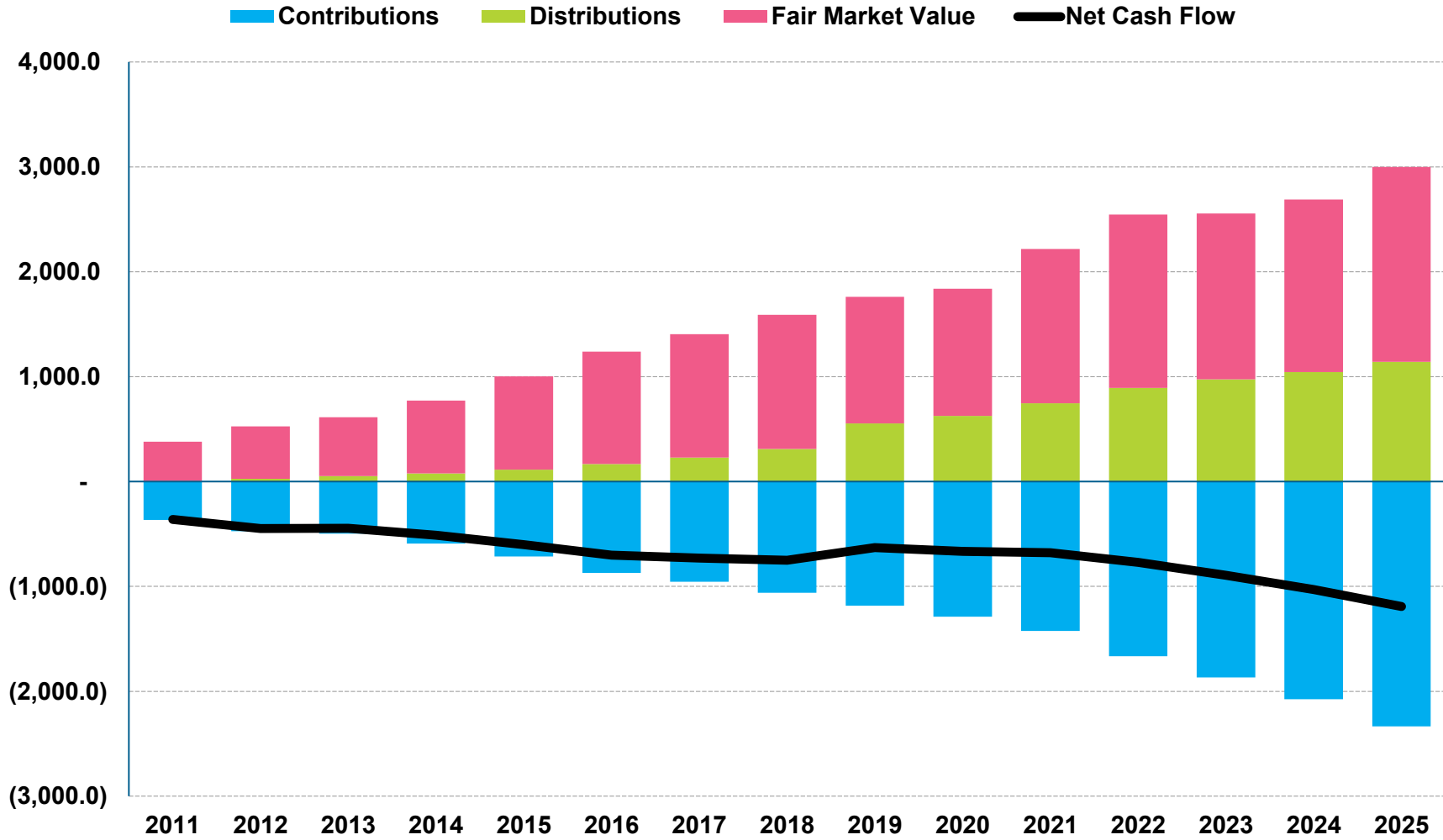

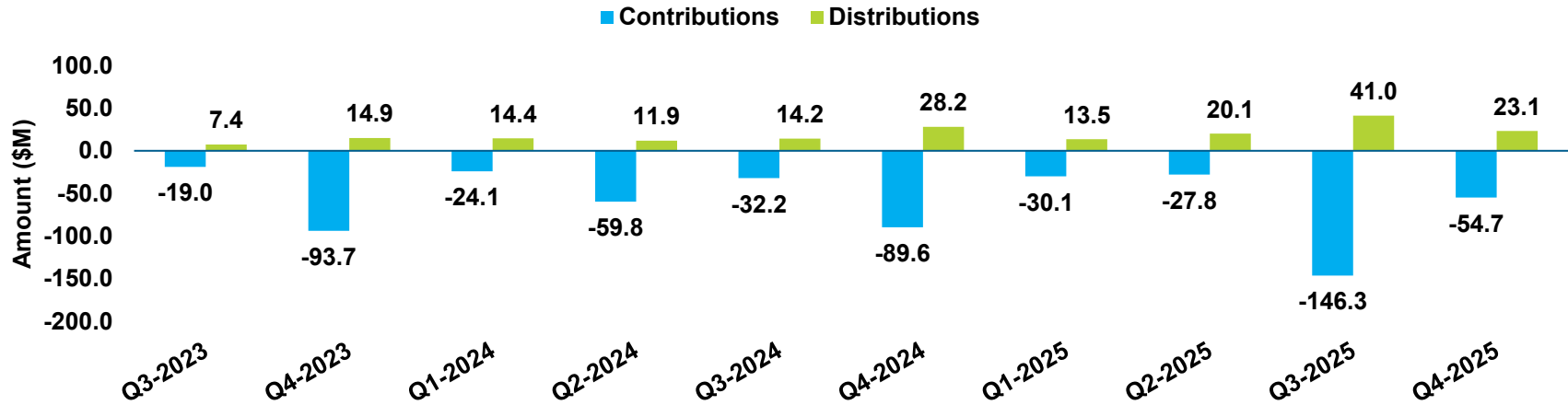

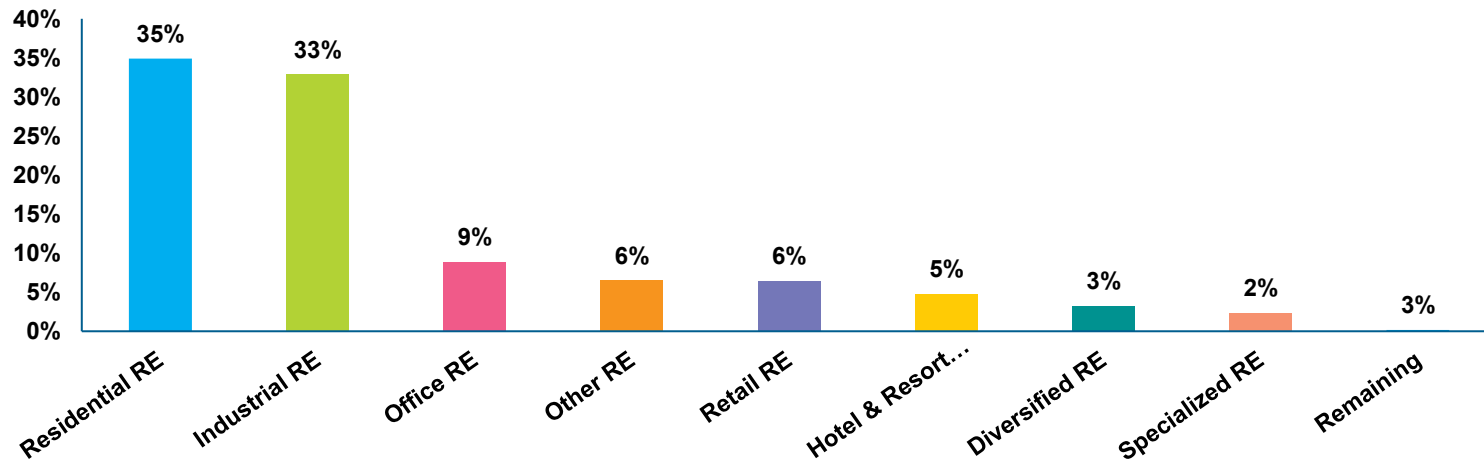

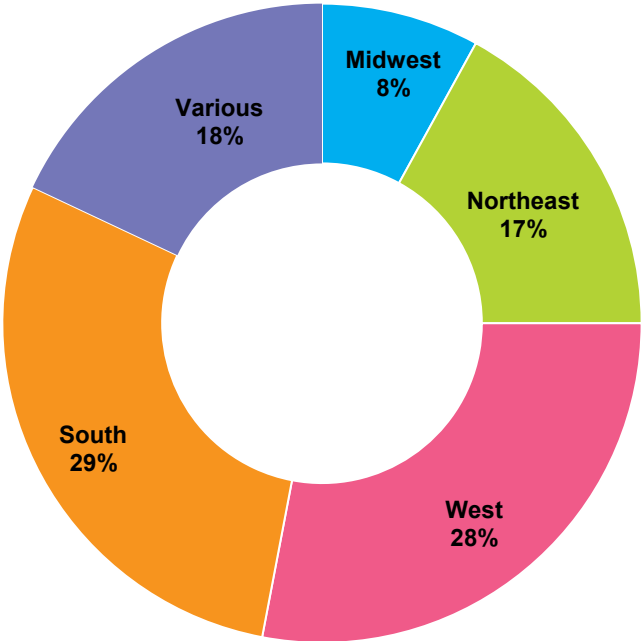


Property Type¹

Below are details on specific terminology and calculation methodologies used throughout this report:

Committed	The original commitment amount made to a given fund. Some funds may be denominated in non-USD currencies, and such commitment amounts represent the sum of fund contributions translated to USD at their daily conversion rates plus the unfunded balance translated at the rate as of the date of this report.
Contributed	The amount of capital called by a fund manager against the commitment amount. Contributions may be used for new or follow-on investments, fees, and expenses, as outlined in each fund's limited partnership agreement. Some capital distributions from funds may reduce contributed capital balances. Some funds may be denominated in non-USD currencies, and such aggregate contributions represent the sum of each fund contribution translated to USD at its daily conversion rate.
Distributed	The amount of capital returned from a fund manager for returns of invested capital, profits, interest, and other investment related income. Some distributions may be subject to re-investment, as outlined in each fund's limited partnership agreement. Some funds may be denominated in non-USD currencies, and such aggregate distributions represent the sum of each fund distribution translated to USD at its daily conversion rate.
DPI	Acronym for "Distributed-to-Paid-In", which is a performance measurement for Private Market investments. The performance calculation equals Distributed divided by Contributed. DPIs for funds and groupings of funds are net of all fund fees and expenses as reported to by fund managers to Meketa.
Exposure	Represents the sum of the investor's Unfunded and Remaining Value.
IRR	Acronym for "Internal Rate of Return", which is a performance measurement for Private Market investments. IRRs are calculated by Meketa based on daily cash flows and Remaining Values as of the date of this report. IRRs for funds and groupings of funds are net of all fund fees and expenses as reported by fund managers to Meketa.
NCV	Acronym for "Net Change in Value", which is a performance measurement for Private Market investments. The performance calculation equals the appreciation or depreciation over a time period neutralized for the impact of cash flows that occurred during the time period.
NM	Acronym for "Not Meaningful", which indicates that a performance calculation is based on data over too short a timeframe to yet be meaningful or not yet possible due to inadequate data.
