Requests are worked in the order they are received. Search and processing times may vary. An OHP collision report number or citation number is required to process your request. Requests will be returned if received without a payment or without sufficient case information for search purposes.

## INSTRUCTIONS/INFORMATION

The Dash Cam Video Production Unit is responsible for receiving, processing, and maintaining all Oklahoma Highway Patrol videos. Pursuant to Oklahoma law, portions of dash cam videos are open record.
